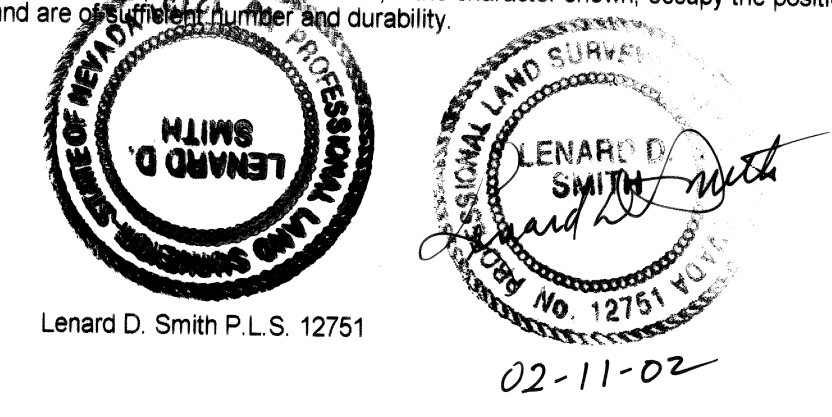


**SURVEYOR'S CERTIFICATE**

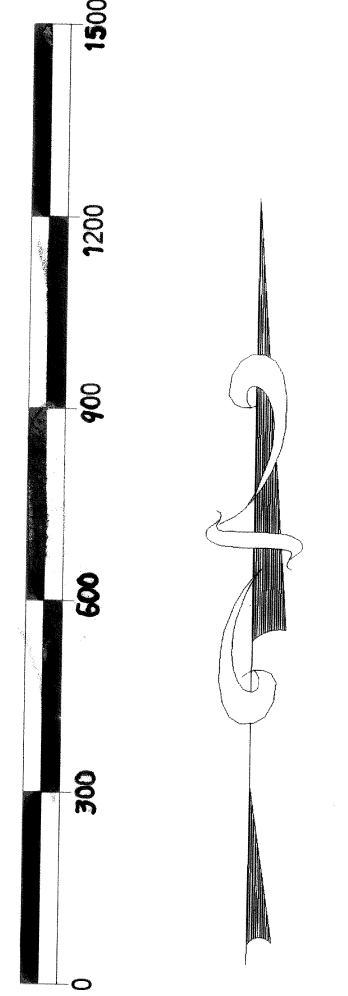

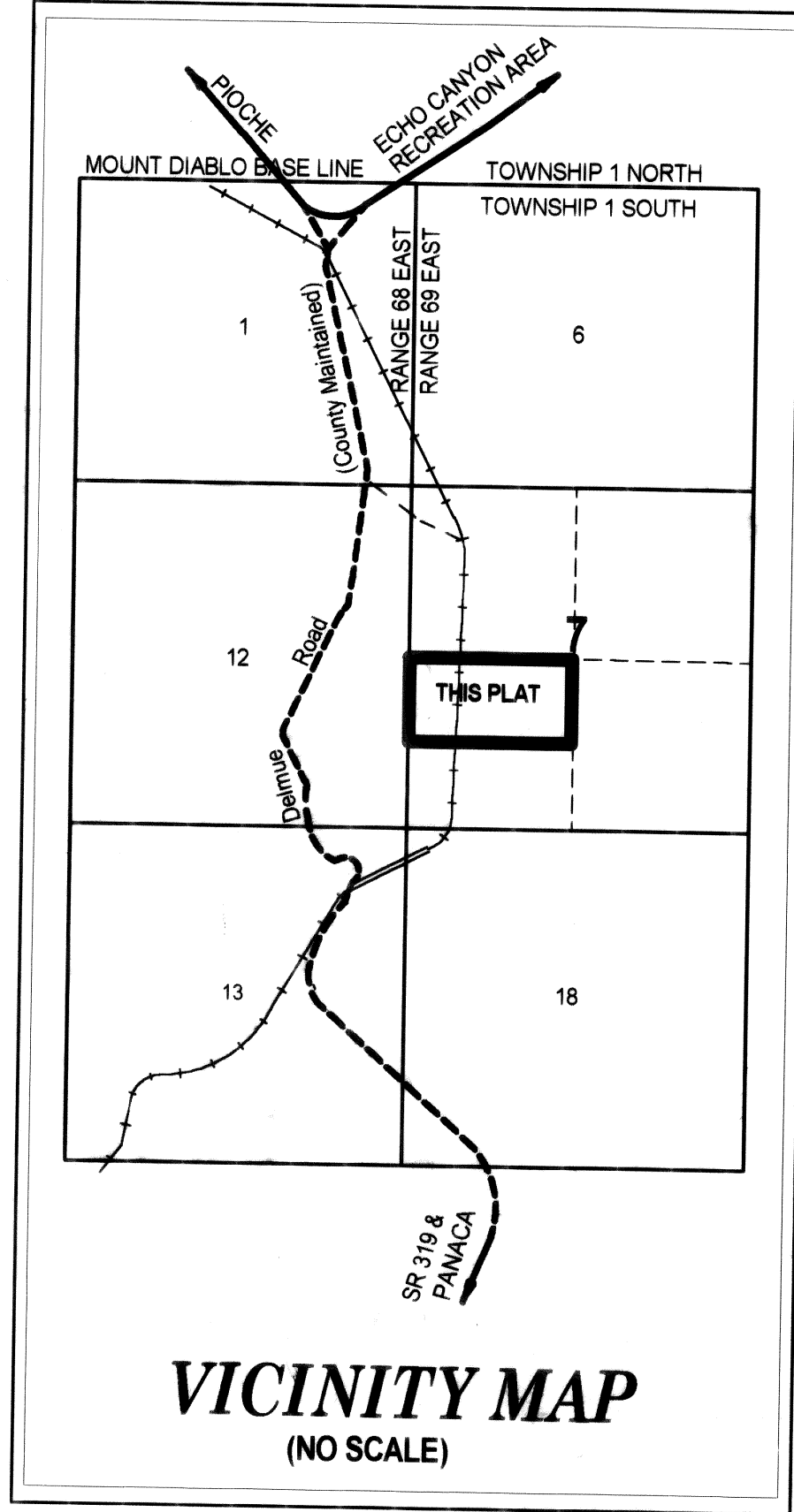


**BASIS OF BEARINGS**
