ORDER GRANTING IMPOSITION OF A LIEN

This matter came before the Court upon Petition of STATE OF NEVADA, DEPARTMENT OF HUMAN RESOURCES, DIVISION OF WELFARE, ("Nevada State Welfare Division" or "NSWD"). CLARK A. RAY, appeared in proper person in opposition to the Petition. The Petitioner, NSWD, did not make an appearance. At the time of the hearing, no written opposition was filed. However, on January 24, 2002, the day before the scheduled hearing, the Court received a letter from MR. RAY which included a copy of a recorded Joint Tenancy Deed dated June 17, 1975, showing MR. RAY as a joint tenant on the subject property. MR. RAY also challenged the Medicaid charges listed for 1996 and 1997 totaling nine hundred ninety three dollars and ten cents (\$993.10).

The Court having read the Petition, noting proof of proper notice (see attached Affidavit of Publication), and having considered the proof and arguments presented thereto, therefore finds that a lien is appropriate and that there is good cause to impose a lien on the subject property and hereby makes its order as follows:
