ORDER GRANTING IMPOSITION OF A LIEN

This matter came before the Court upon Petition of STATE OF NEVADA, DEPARTMENT OF HUMAN RESOURCES, DIVISION OF WELFARE, ("Nevada State Welfare Division" or "NSWD"). CLARK A. RAY, appeared in proper person in opposition to the Petition. The Petitioner, NSWD, did not make an appearance. At the time of the hearing, no written opposition was filed.
