now requested that the Court cancel this lis pendens, and good cause appearing therefor.





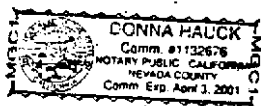
