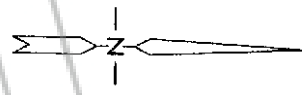
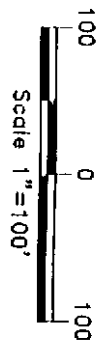

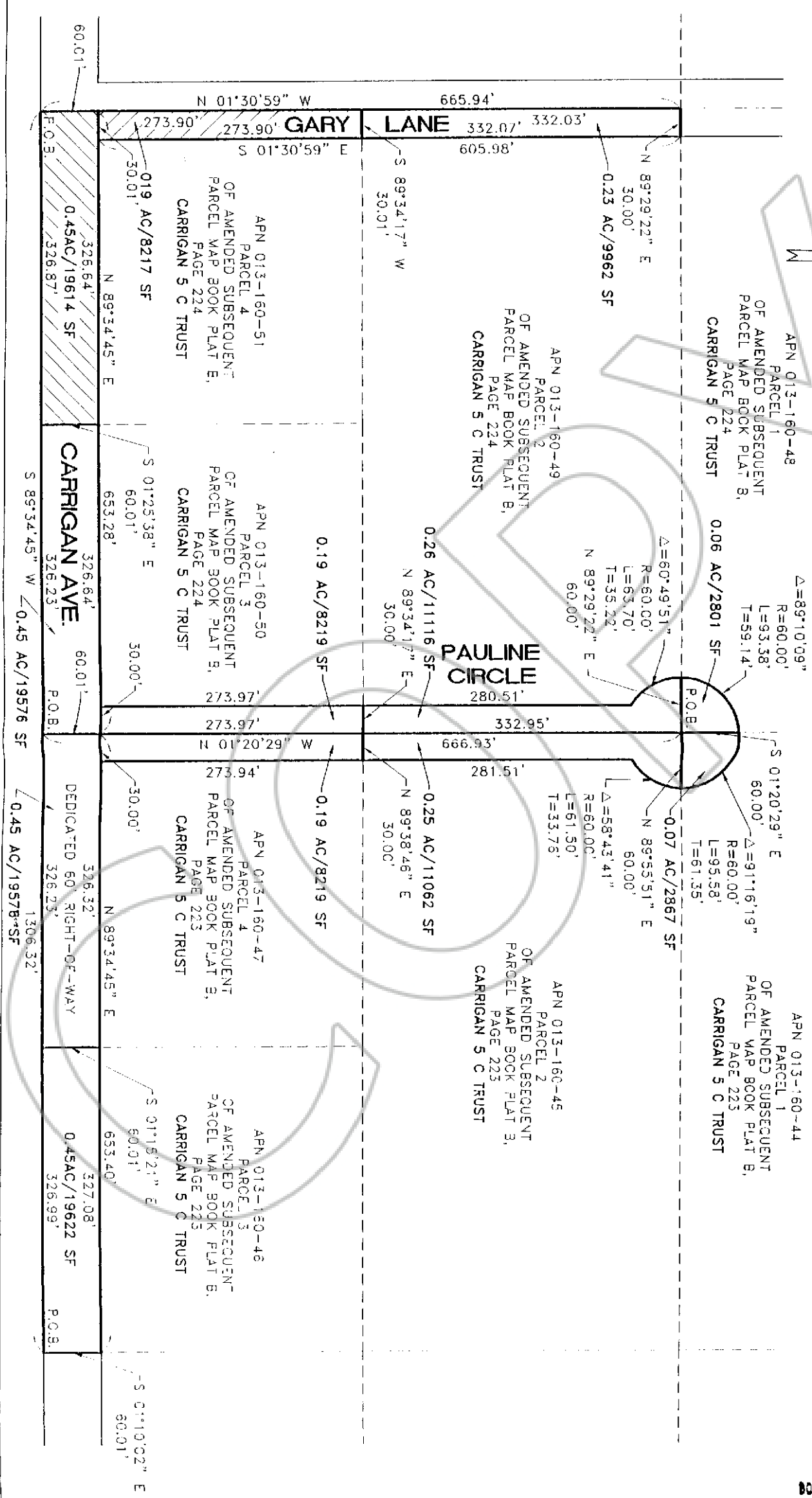

Thence N. 89°34'45" E. a distance of 326.64 feet to the NE Corner of said strip of land;
Thence S. 01°25'38" E. a distance of 60.01 feet to the SE Corner of said strip of land and the SE Corner of said Parcel 4;
Thence S. 89°34'45" W. a distance of 326.87 feet to the said SW Corner of said strip of land and the point of beginning;

Containing 0.45 Acre or 19614 Square Feet, more or less.

Beginning at a point on the northerly right-of-way of Carrigan Avenue, whence the SW Corner of said Parcel 4 bears S. 01°30'59" E. a distance of 60.01 feet
Thence N. 01°30'59" W. a distance of 273.90 feet to the NW Corner of said strip of land and the NW Corner of said Parcel 4;
Thence N. 89°34'17" E. a distance of 30.01 feet to the NE Corner of said strip of land;
Thence S. 01°30'59" E. a distance of 273.90 feet to the SE Corner of said strip of land;
Thence S. 89°34'45" W. a distance of 30.01 feet to the said SW Corner of said strip of land and point of beginning;
