PERMANENT EASEMENT

THIS INDENTURE OF EASEMENT, made and entered into by and between:

COYOTE SPRINGS INVESTMENT LLC, A NEVADA LIMITED LIABILITY COMPANY

Party of the First Part, hereinafter known as the GRANTOR(S), and SOUTHEN NEVADA WATER AUTHORITY, a political subdivision of the State of Nevada, hereinafter known as the AUTHORITY.

WITNESSETH:

That the **GRANTOR**(S), for and in consideration of the sum of one dollar (\$1.00), lawful money of the United States, to it in hand paid by the **AUTHORITY**, the receipt whereof is hereby acknowledged, does by these presents GRANT and CONVEY to the **AUTHORITY**, its successors and assigns, a Permanent Easement and Right of Way for the purpose of construction, operation, maintenance, repair, renewal, reconstruction and plugging and abandonment of a monitoring well and appurtenances, with the right of ingress and egress, over, above, and across that certain parcel of land located in the North One-Half (N1/2) of the Northwest One-Quarter (NW1/4) of the Southwest One-Quarter (SW1/4) of Section 13, Township 11 South, Range 63 East, M. D. M., and more particularly described as follows:

SEE EXHIBIT "A" ATTACHED TO AND BY THIS REFERENCE MADE A PART HEREOF.

The GRANTOR(S), its successors and assigns agree that

- No buildings, structures, fences or trees shall be placed upon, over or under said parcel of land, now or hereafter, except that said parcel may be improved and used for street, road or driveway purposes and for other utilities, insofar as such use does not interfere with its use by the AUTHORITY for the purposes for which it is granted;
- The AUTHORITY shall not be liable for any damage to any of the GRANTOR'S
 improvements placed upon said parcel due to the AUTHORITY'S necessary operations using reasonable care;
 and
- 3. The AUTHORITY shall have reasonable ingress and egress over, above, and across the aforementioned parcel described above, for all equipment necessary to drill and complete a monitoring well within the easement area described in EXHIBIT "A".

- 4. In the event that the monitoring well would no longer be required, the GRANTOR(S), or its successors and assigns, shall allow the AUTHORITY reasonable access over, above and across the aforementioned described parcel, for the purpose of dismantling, plugging and abandoning said monitoring well within the easement area described in EXHIBIT "A", in accordance with laws of the State of Nevada.
- 5. Should any of the **AUTHORITY'S** facilities within said easement be required to be relocated or repaired as a result of changes in grade or other construction within the easement, the **GRANTOR**(S), or its successors and assigns, shall bear the full cost of such relocation or repair, unless the changes in grade or other construction were done by third parties with the written consent of the **AUTHORITY**.

The AUTHORITY, its successors and assigns, agrees that

- 1. Upon completion of the drilling of the monitoring well and installation of related monitoring devices, all equipment used to install said monitoring well shall be removed within six (6) months of the date of execution of this document, or by December 31, 2002, or whichever date occurs first.
- 2. In the event that said monitoring well would no longer be required, the AUTHORITY shall notify the GRANTOR(S), its successors or assigns. The AUTHORITY shall dismantle, plug and abandon said monitoring well in accordance with the laws of the State of Nevada, and at no cost to the GRANTOR(S), its successors or assigns.




