SUBSTITUTION OF TRUSTEE

ZIONS BANK is hereby appointed Successor Trustee under that certain Trust Deed executed by R Chad Young and Brenda Z Young, joint tenancy, as Trustor, in which Nevada State Bank is named Beneficiary and Zions First National Bank, as Trustee, and recorded May 30, 2001, with Entry No. 116410, in Book 115 on the records of Lincoln County, Nevada. This appointment is hereby made by Nevada State Bank, the present Beneficiary under said Trust Deed.

The real property which the Trust Deed describes is as follows, and is located in Lincoln County, State of Nevada:

All that certain real property situate in the County of Lincoln, State of Nevada, described as follows:

Being a portion of the Northwest Quarter (NW ¼) of the Southeast Quarter (SE ¼) and the Northeast Quarter (NE ¼) of the Southwest Quarter (SW ¼) of Section 7, Township 4 South, Range 67 East, Mount Diablo Base and Meridian, and described as follows:

Beginning at the Northeast corner of Parcel No 5, from which point the Southeast corner of said Section 7 bears South 51 deg 35'15" East, at 2698.76 feet; thence south 48 deg 05'03" West 299.96 feet; thence North 63 deg 25'00" West 654.11 feet; thence North 54 deg 23'36" East, 275.31 feet; thence North 19 deg 42'52" West, 83.97 feet; thence North 32 deg 41'25" West, 131.81 feet; thence North 53 deg 15'35" East, 67.58 feet; thence south 41 deg 37'44" East, 492.06 feet; thence North 41 deg 17'18" East, 151.35 feet; thence South 41 deg 33'25" East, 305.94 feet to the point of beginning. Together with a private road as conveyed by Deed recorded February 5, 2001 in Book 153 of Official Records, Page 190 as File No 115929, Lincoln County, Nevada records. Beginning at the Northwesterly corner of said private lane monumented by a rebar & cap stamped L Smith PLS 12751, at a point from which the Southwest corner of said Section 7, a standard BLM brass cap, bears South 62 deg 40'37" West, 2582.64 feet, thence North 43 deg 31'35" East, 451.19 feet along the BLM yard Southeast Boundary to a 3 inch OD pipe 5'3" high, thence South 63 deg 24'52" East, 41.06 feet to a rebar & cap stamped L Smith PLS 12751, thence South 43 deg 31'35" West, 455.61 feet to a rebar and cap stamped L Smith PLS 12751, thence North 57 deg 21'07" West 40.00 feet to the point of beginning. Containing 17,810 square feet more or less. The basis of bearing is the South line of said Section 7 being South 88 deg 52'20" East, end of description.

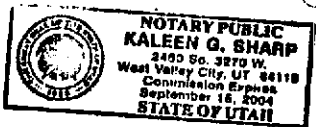
