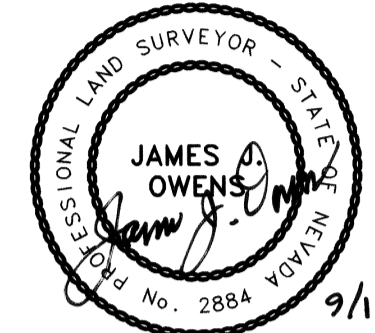


REVERSION to ACREAGE MAP

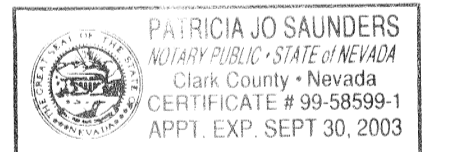

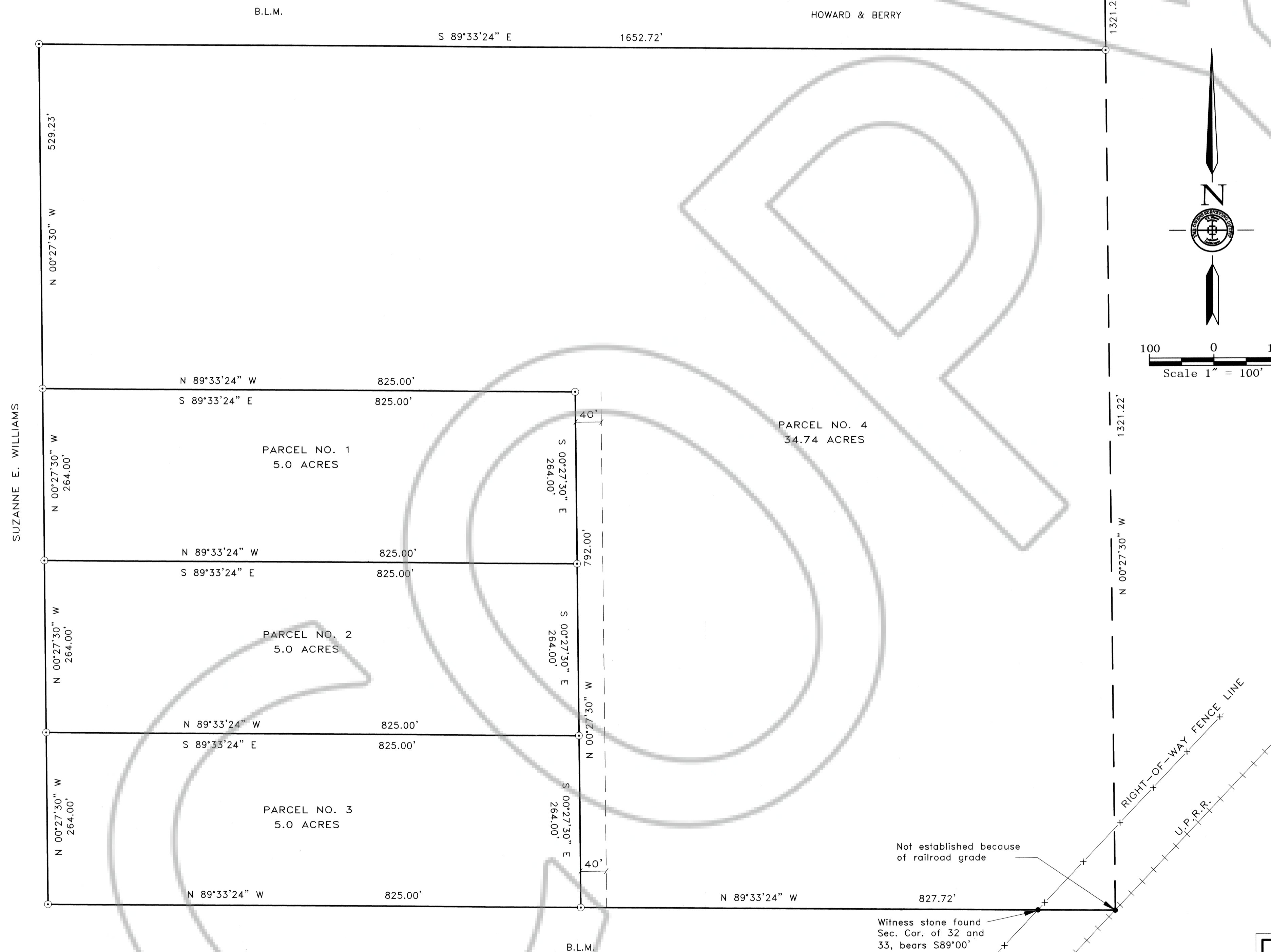

A PORTION OF THE SW1/4 AND SE 1/4 OF SECTION 32, T4S, R70E, M.D.B. & M.

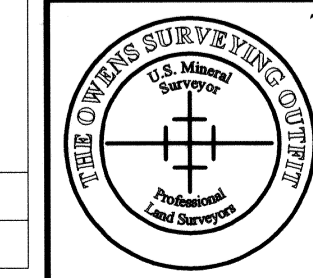
