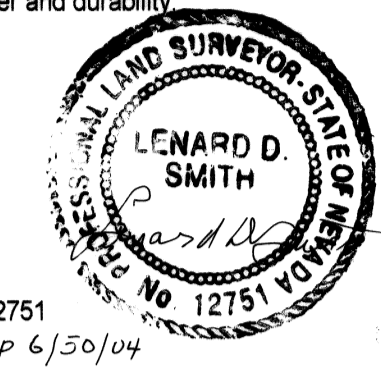

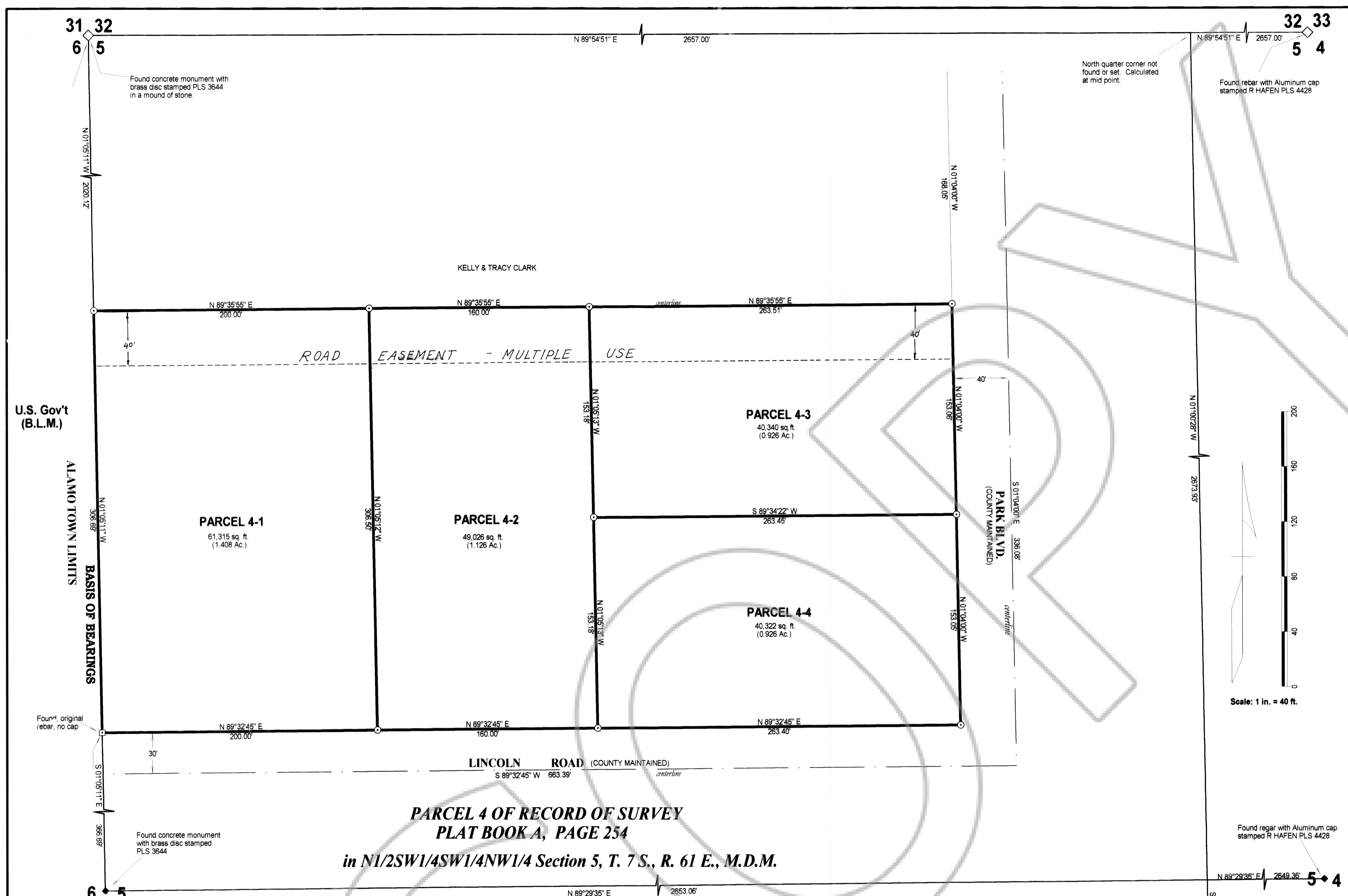

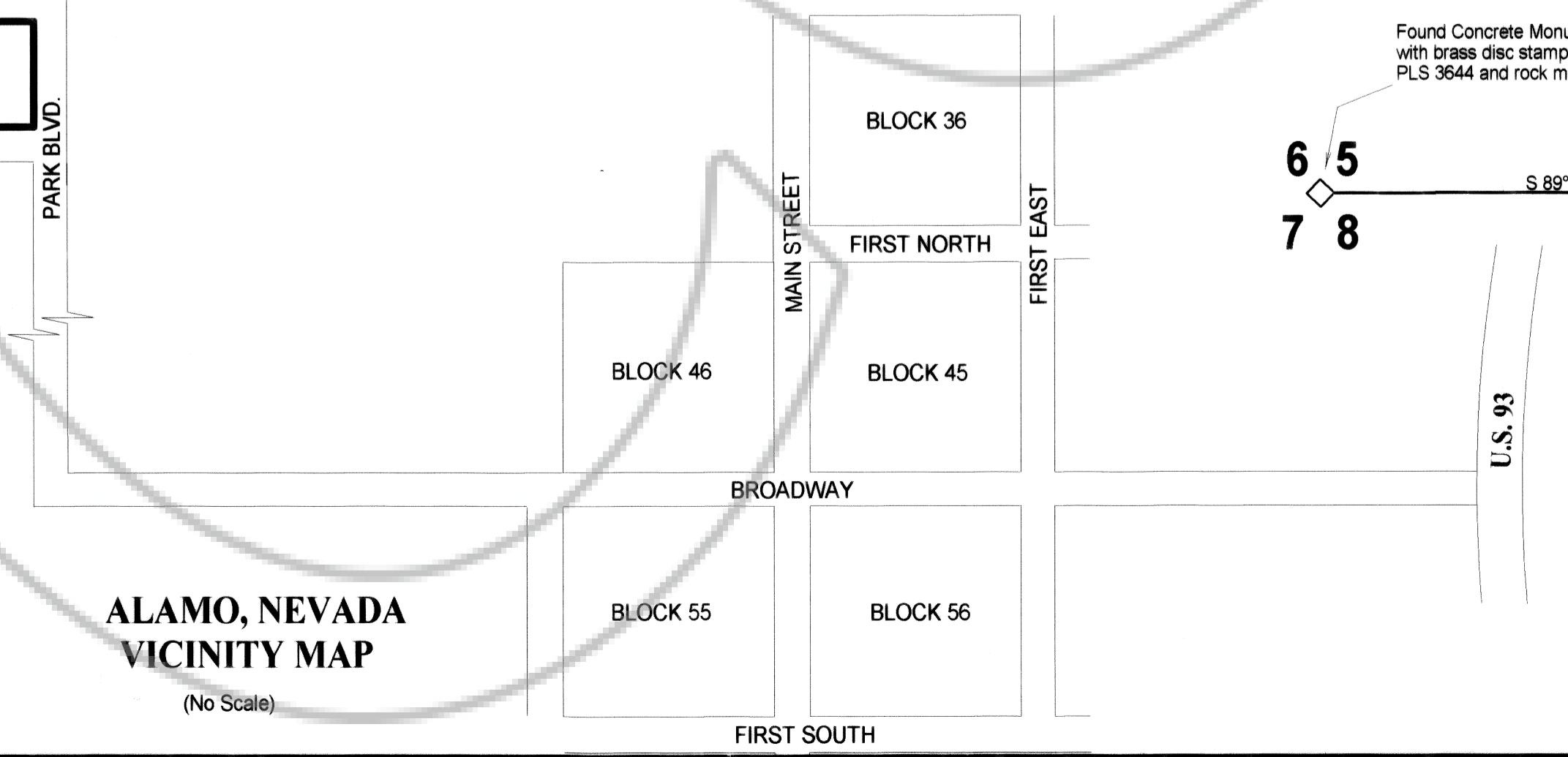
PARCEL MAP
