DEED OF TRUST WITH ASSIGNMENTS OF RENTS

THIS DEED OF TRUST, made December 12, 2002, between **Steven J. Anderson and Carolyn D. Anderson, husband and wife as joint tenants with right of survivorship, TRUSTOR**, whose address is **P. O. Box 547, Alamo, NV 89001, First American Title Company of Nevada, a Nevada Corporation, TRUSTEE**, and **Elaine Shumway, BENEFICIARY**, whose address is **P. O. Box 175, Alamo, NV 89001**.

WITNESSETH: That Trustor grants to Trustee in trust, with power of sale, that property in the County of Lincoln, State of Nevada, described as:

That portion of Lot Three (3) in Block Fifty-Seven (57) to Alamo Townsite as shown by map thereof recorded as File No. 1176 in the Office of the County Recorder of Lincoln County, Nevada, described as follows:

Commencing at the Southwest corner of Lot 3 in Block 57 within Alamo Townsite and running thence North 161 feet; thence East 66 feet; thence South 161 feet; thence West 66 feet to the point of beginning.

Note: the above metes and bounds description appeared previously in that certain document recorded July 20, 1961 in Book L-1 of Deeds, Page 395 in the Office of the County Recorder of Lincoln County, Nevada.

Together with the rents, issues and profits, thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, and profits.

For the purposes of securing (1) payment of the sum of **FIFTEEN THOUSAND AND NO/100 dollars (\$15,000.00)** with interest thereon according to the terms of the promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewal thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust.

To protect the Security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the Office of each County Recorder in the State of Nevada on January 30, 1968, in the book and at the page thereof, or under the document or file number, noted below opposite the name of such county, namely:

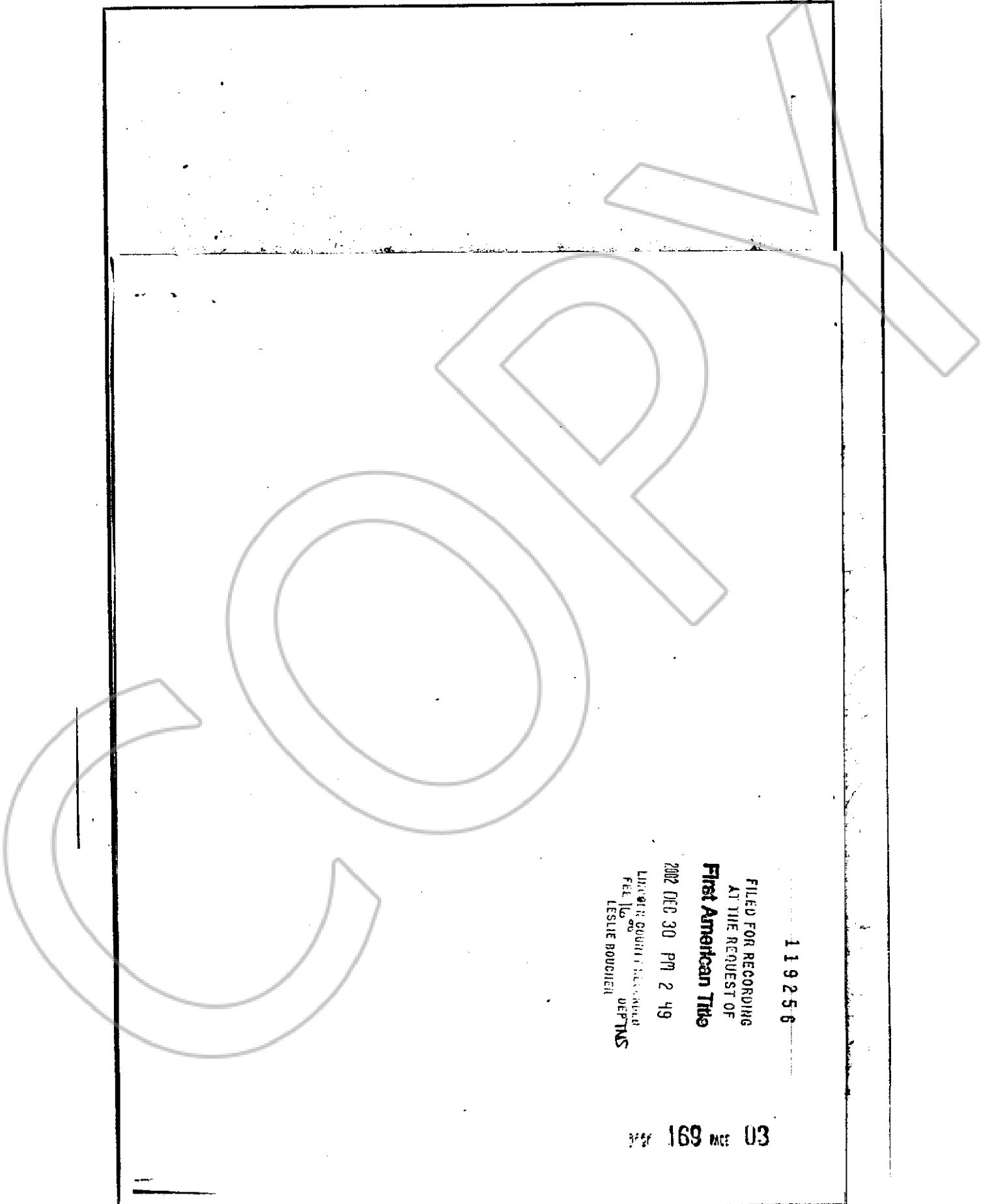
