## ASSIGNMENT OF RENTS

THIS ASSIGNMENT OF RENTS dated July 8, 2003, is made and executed between Coyote Springs Investment LLC, whose address is 7755 Spanish Springs Road, Sparks, NV 89436 (referred to below as "Grantor") and BANK OF THE WEST, whose address is 4950 Kietzke Lane, Reno, NV 89509 (referred to below as "Lender").

Right to Assign. Grantor has the full right, power and authority to enter into this Assignment and to essign and convey the Rents to Lender.

LENDER'S RIGHT TO RECEIVE AND COLLECT RENTS. Lender shall have the right at any time, and even though no default shall have occurred under this Assignment, to collect and receive the Rents. For this purpose, Lander is hereby given and granted the following rights, powers and authority:

Notice to Tenants. Lender may send notices to any and all tenants of the Property advising them of this Assignment and directing all Rents to be paid directly to Lender or Lender's agent.

Enter the Property. Lender may enter upon and take possession of the Property; demand, collect and receive from the terrents or from any other persons liable therefor, all of the Rents; institute and carry on all legal proceedings necessary for the protection of the Property, including such proceedings as may be necessary to recover possession of the Property; collect the Rents and remove any tenant or tenants or other persons from the Property.

Maintain the Property.
