BASEMENT AGREEMENT

WHEREAS, SCHMUTZ is desirous of obtaining a right-of-way and easement over, under and across a portion of said property for the installation, operation, maintenance and repair of a roadway, and for underground utilities; and

WHEREAS, CANNON is desirous and willing to grant said easement and the right-of-way for the purposes herein set forth;

NOW, THEREFORE, for and in consideration of the premises and the terms, covenants, agreements and conditions hereinafter set forth, CANNON agrees as follows:

To, and he does hereby, assign, grant and convey unto SCHMUTZ an easement and right-of-way for a roadway and for underground utilities, under and across the hereinafter described tract of land and owned by said CANNON, and said tract of land, which said tract of land is more particularly described on Exhibit "A" attached hereto and made a part hereof, and is further set forth on the map attached hereto as Exhibit "B" and made a part

- This Agreement shall be binding upon and inure to the benefit of the heirs, successors, legal representatives and assigns of the respective parties hereto.
- Any party causing damage to the easement, shall repair the same immediately at their sole cost and expense.
- Either party shall be allowed to construct improvements to the easement at their sole cost and and expense provided the improvements so constructed do not interfer with the
