The Court held a hearing on the 8th day of September, 1990. The parties litigated the ownership of the property they were involved with. The parties lived together for many years, but never married. The parties offered evidence and based upon that, the Court ruled from the Bench that ANN ARMSTRONG owed a ring, a Toyota Car and one-fourth (1/4) interest in a well. GAIL ARMSTRONG owed a home, rental property, butcher shop and pickup truck. The parties keep their income separate and the individual income belongs to each of them. The issue of whether MR. ARMSTRONG is entitled to any sum for compensation for services as a housekeeper has not been resolved. No temporary support Order was granted. The parties live together voluntarily, they keep their own income separately, both

are very elderly. GAIL ARMSTRONG pays almost all expenses and has provided insurance and substantial cash for ANN ARMSTRONG'S health problems. GAIL ARMSTRONG has no legal responsibility to provide a home for ANN ARMSTRONG, he does so voluntarily. Both parties testified they live together peacefully, under these unusual circumstances. The Court saw no reason to enter an Order that would end their relationship.
