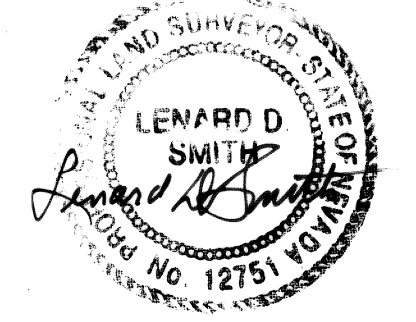


SURVEYOR'S CERTIFICATE

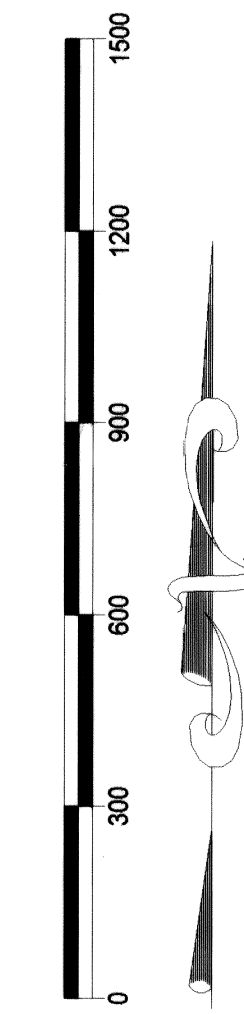

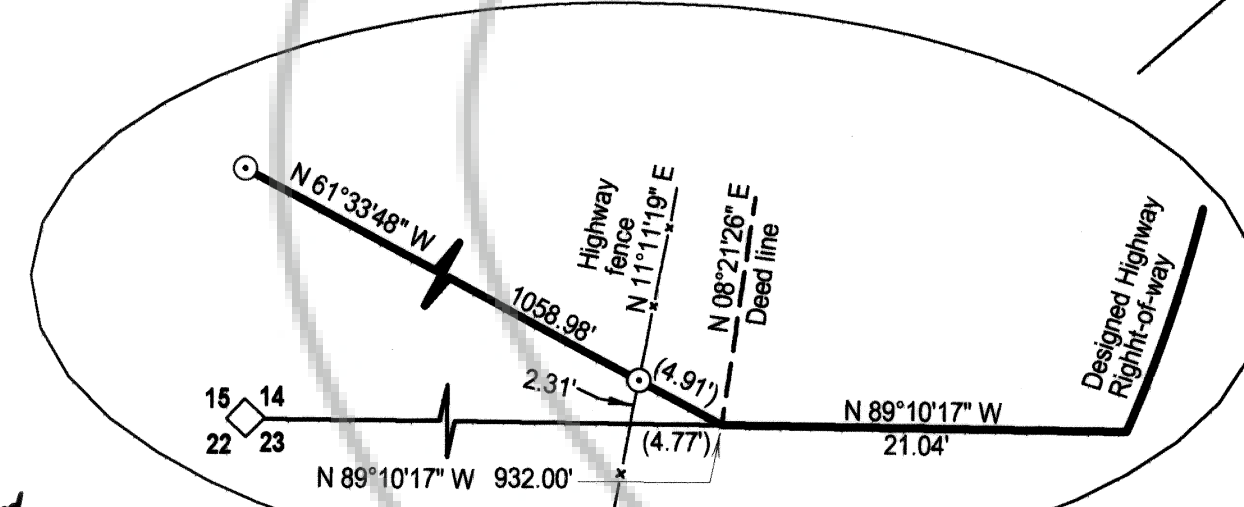
MAP NOTES
