It appearing to the satisfaction of the Court that a verified Petition to set aside the Nevada Estate of the above named decedent without administration has been filed, and that notice of the time and place of the hearing thereon has been duly given in the manner required by law, and hat no one has objected or presented any reason why said Petition should not be granted.

6 IT IS THEREFORE ORDERED ADJUDGED AND DECREED by the Court that the  
7 whole of the Nevada estate of BARBARA BRINJAC, deceased, be, and the same is hereby  
8 assigned and set aside to, and the title thereof shall vest absolutely in:
