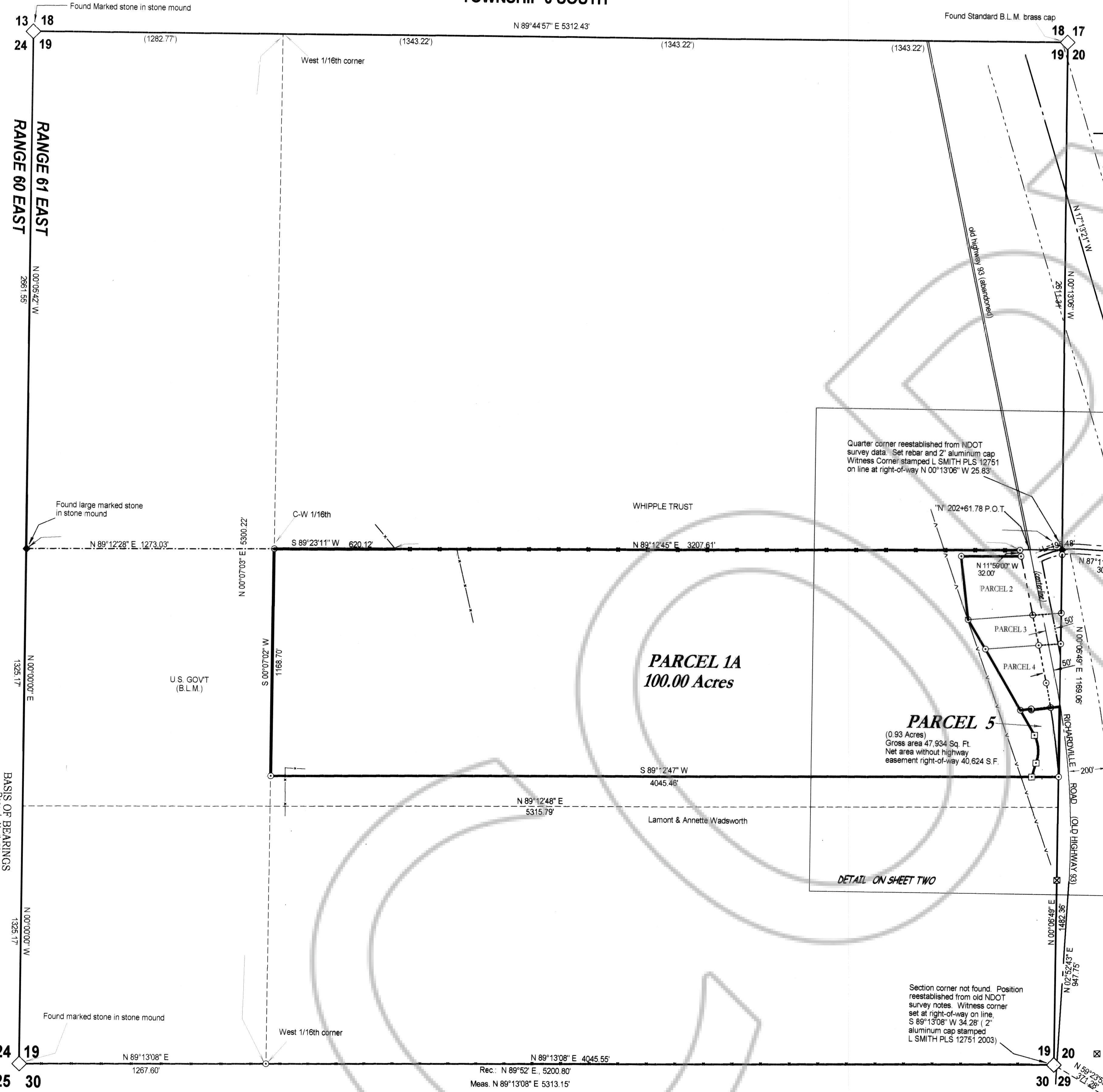
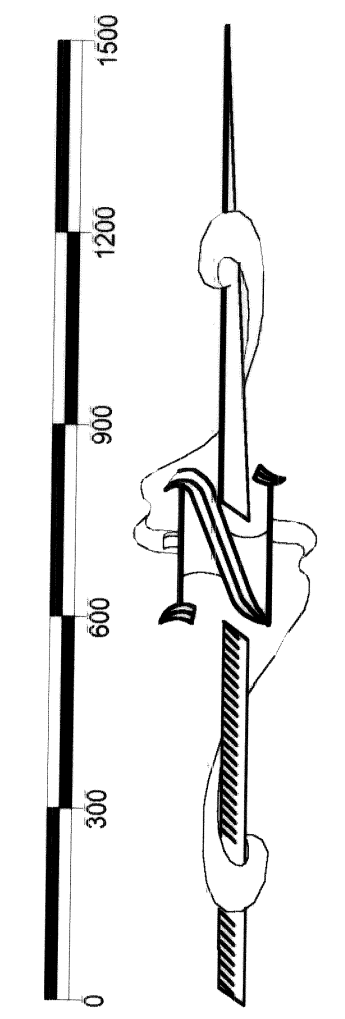
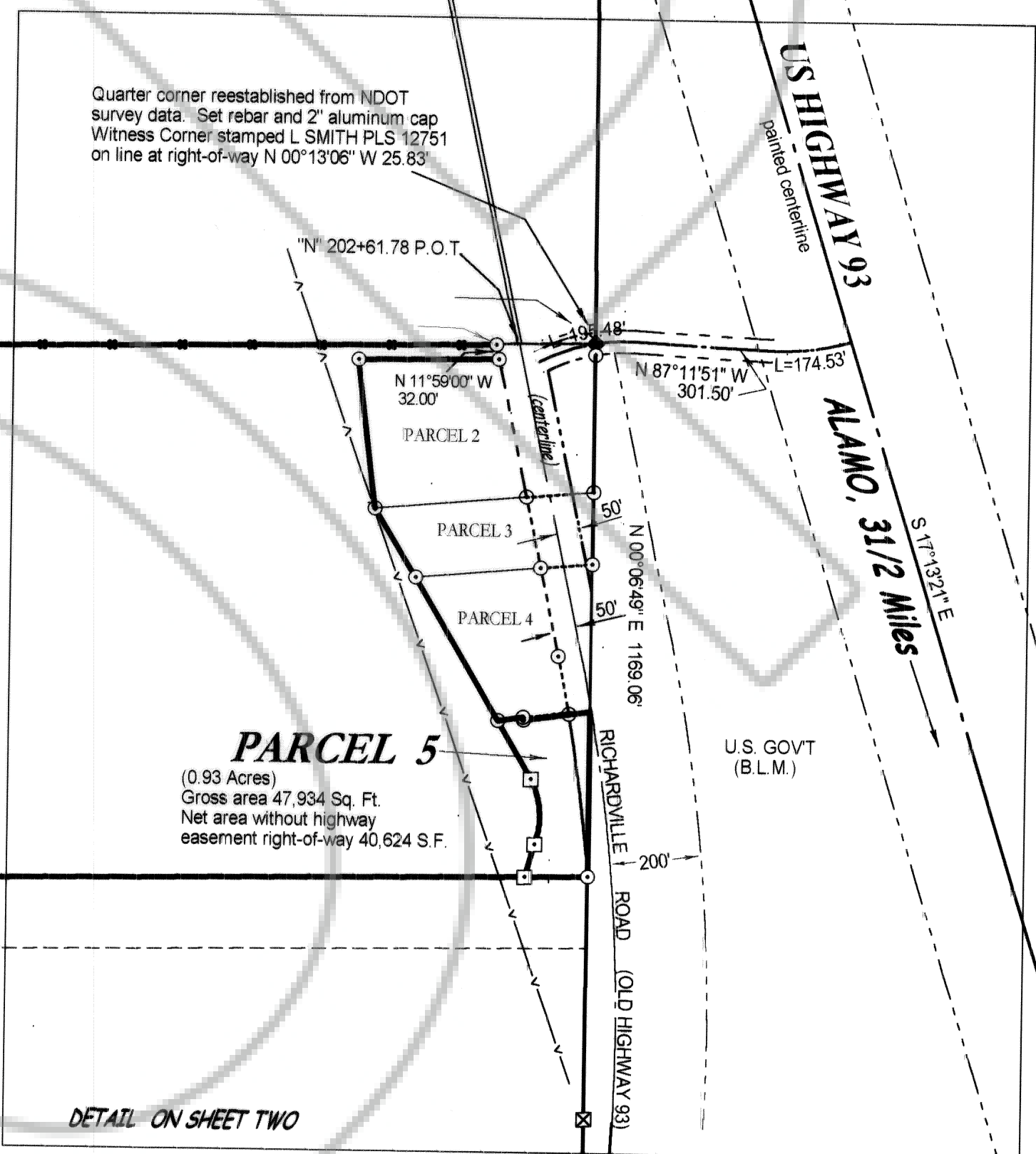


TOWNSHIP 6 SOUTH

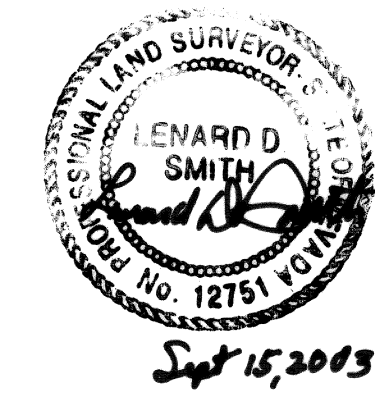

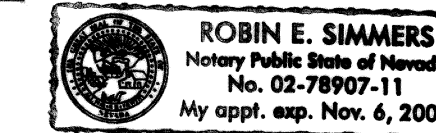

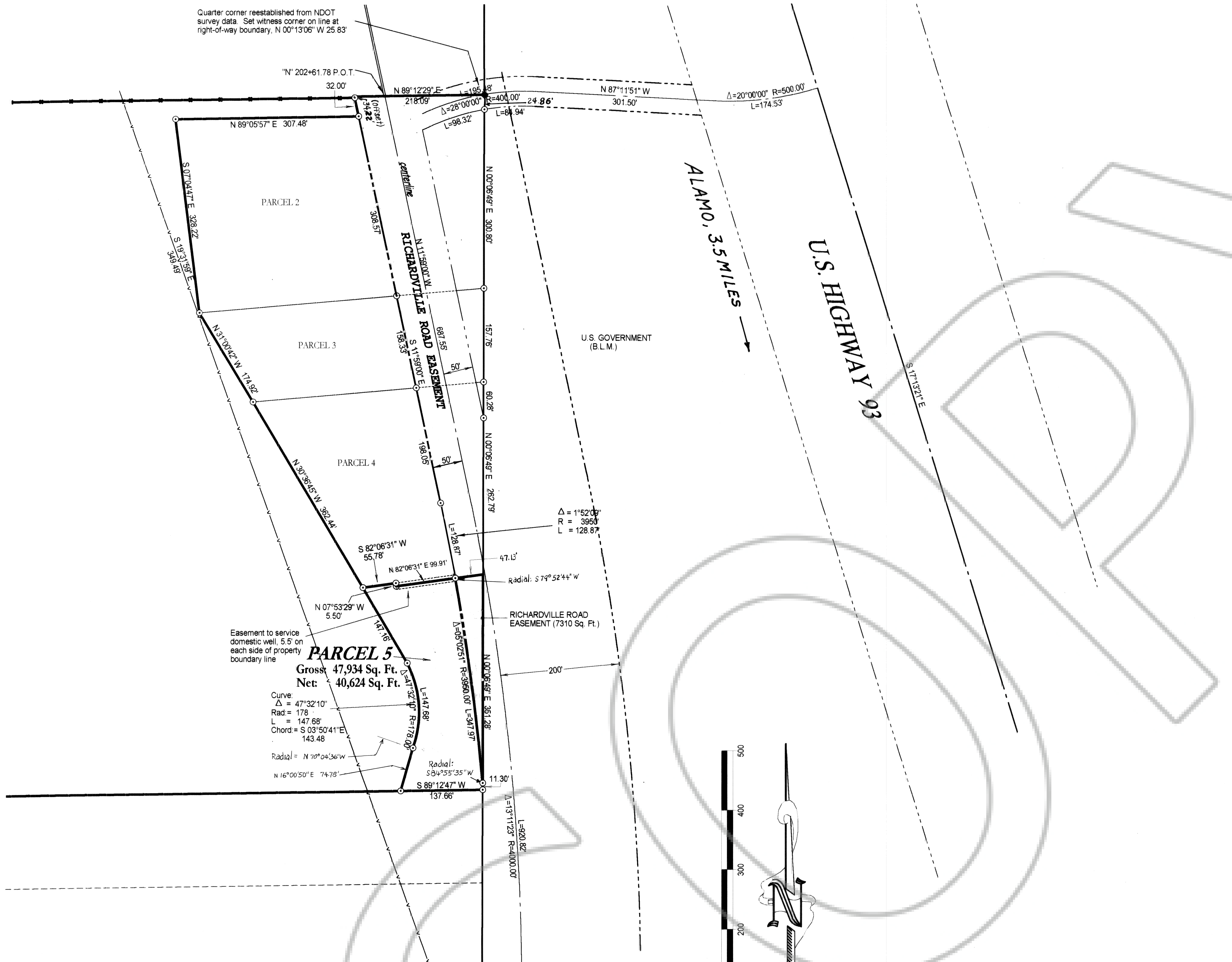
