**CERTIFICATE OF LOCATION**

Has located the MAG #220 Lode Mining Claim on the 2<sup>nd</sup> day of May, 2004, whose dimensions are 1500 feet by 600 feet. By this Declaration and such location, the above named locator(s) claim all veins, lodes, ledges, deposits, and surface ground within the boundaries of said claim.

Said claim is a lode it being situated in the above mentioned county and state, and it is distinctly marked on the ground so that its boundaries may be readily traced by four 2" X 2" wooden posts four feet long. Each monument is marked with a scribed metal tag, which states the claim name and number and the location of the monument with respect to the claim.

Beginning at the NE corner (Cor. No. 1), thence 600 feet South to the SE Corner (Cor. No. 2), then 1500 feet West to the SW Corner (Cor. No. 3), then 600 feet North to the NW corner (Cor. No. 4), then 1500 feet East to the Point of Beginning.

To tie this claim to a Public Survey, the NE Corner (Cor. No. 1) of this claim lies approximately 6760 feet NORTH and 4500 feet EAST from the NE Corner of Section 35, Township 5 South, Range 64 East, Mount Diablo Base Line and Meridian.


