1 and that there are no further set-offs or counterclaims in favor of the judgment debtor.


2 6. That the exact amount due on the Judgment is \$5786.20, representing the principal

6 per annum until the Judgment is paid in full.

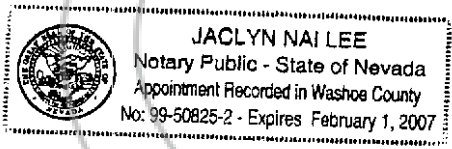
