16 This cause having come on for hearing this day, on the Petition of **Heather**  
17 **Michelle McBride** for an Order Terminating the Parental Rights of **Christopher Patrick**

19 child, **Braiden Connor Collier**, for whom the Petition was brought herein, Petitioner being  
20 present in person and represented by Byron L. Mills, Esq., and there being present in Court  
21 neither the said **Christopher Patrick Collier** aka **Christopher Patrick O'Connor**, nor his  
22 representative and the Court having received evidence to the effect that the said minor child,  
23 **Braiden Connor Collier** is neglected and abandoned within the purview of **Section 128.014**  
24 of N. R. S. Chapter 128 in that **Christopher Patrick Collier** aka **Christopher Patrick**  
25 **O'Connor**, the natural father of the said child, has failed, neglected and refused to provide  
26 proper or necessary subsistence for the support and maintenance of the said minor child for a

1 period in excess of one and one-half years, prior to the filing of the Petition and that the said

3 **Christopher Patrick Collier** aka **Christopher Patrick O'Connor**, natural father, has  
4 abandoned the said minor child, pursuant to N. R. S. 128.012, in that he had failed, neglected  
5 and refused to correspond or communicate with said minor child for period of time prior to the  
6 filing of the Petition, and the Court having received said evidence and considered the same, and  
7 good cause appearing therefor,

9 **IT IS HEREBY ORDERED** that **Christopher Patrick Collier** aka **Christopher**  
10 **Patrick O'Conner**, the natural father of the minor child, be, and he hereby is judicially  
11 deprived of the custody and control of **Braiden Connor Collier**, the minor child, and the  
12 parental rights of the said natural father, be, and the same hereby are terminated.


14 **IT IS HEREBY FURTHER ORDERED** that the name of the said minor child

16 **Connor McBride**.


