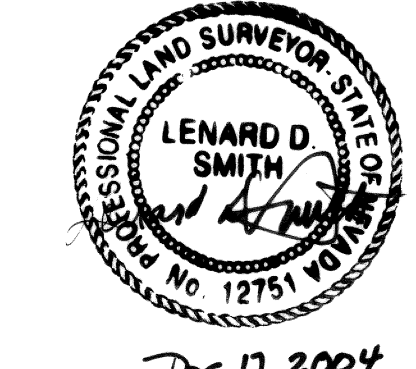

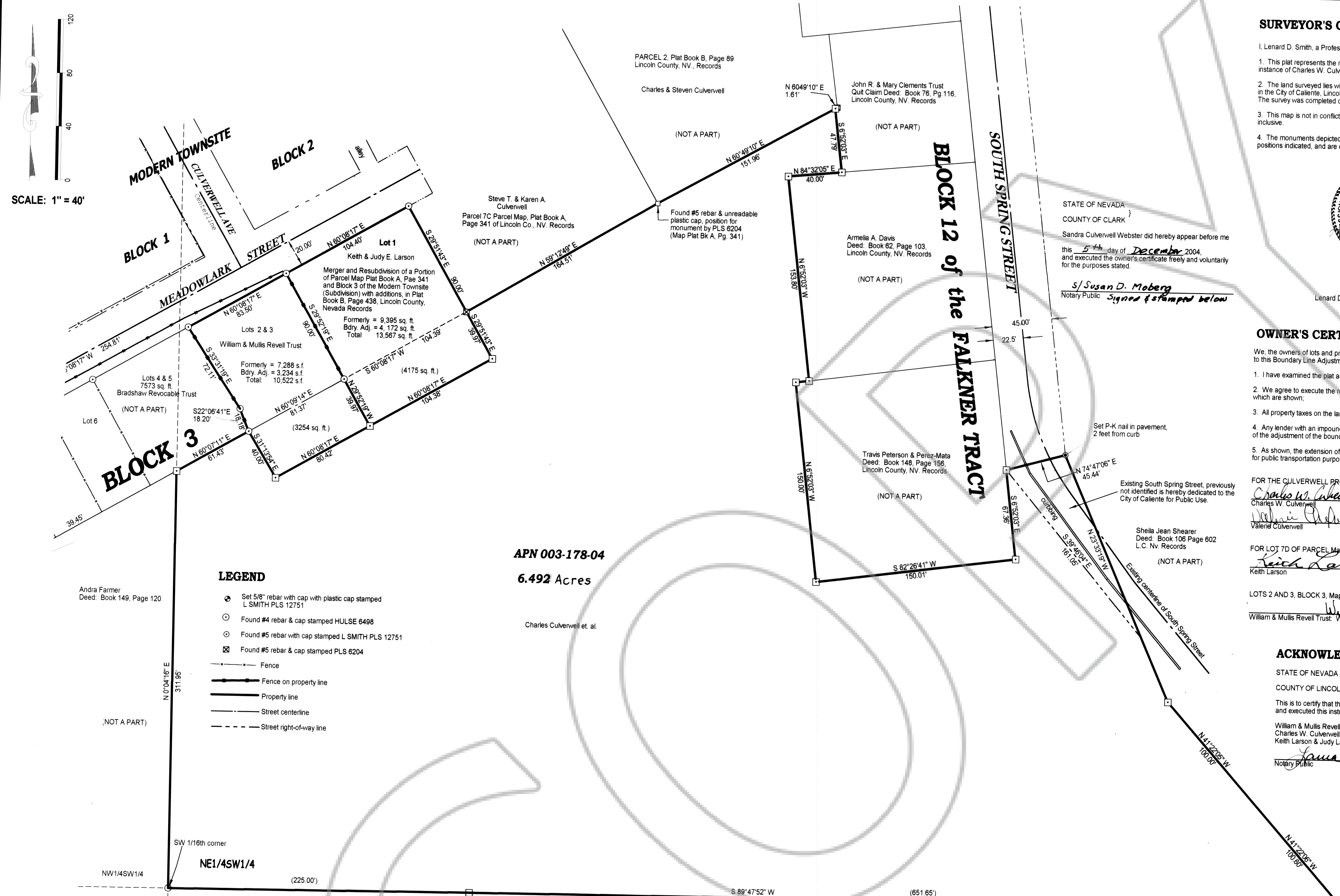

BASIS OF BEARINGS

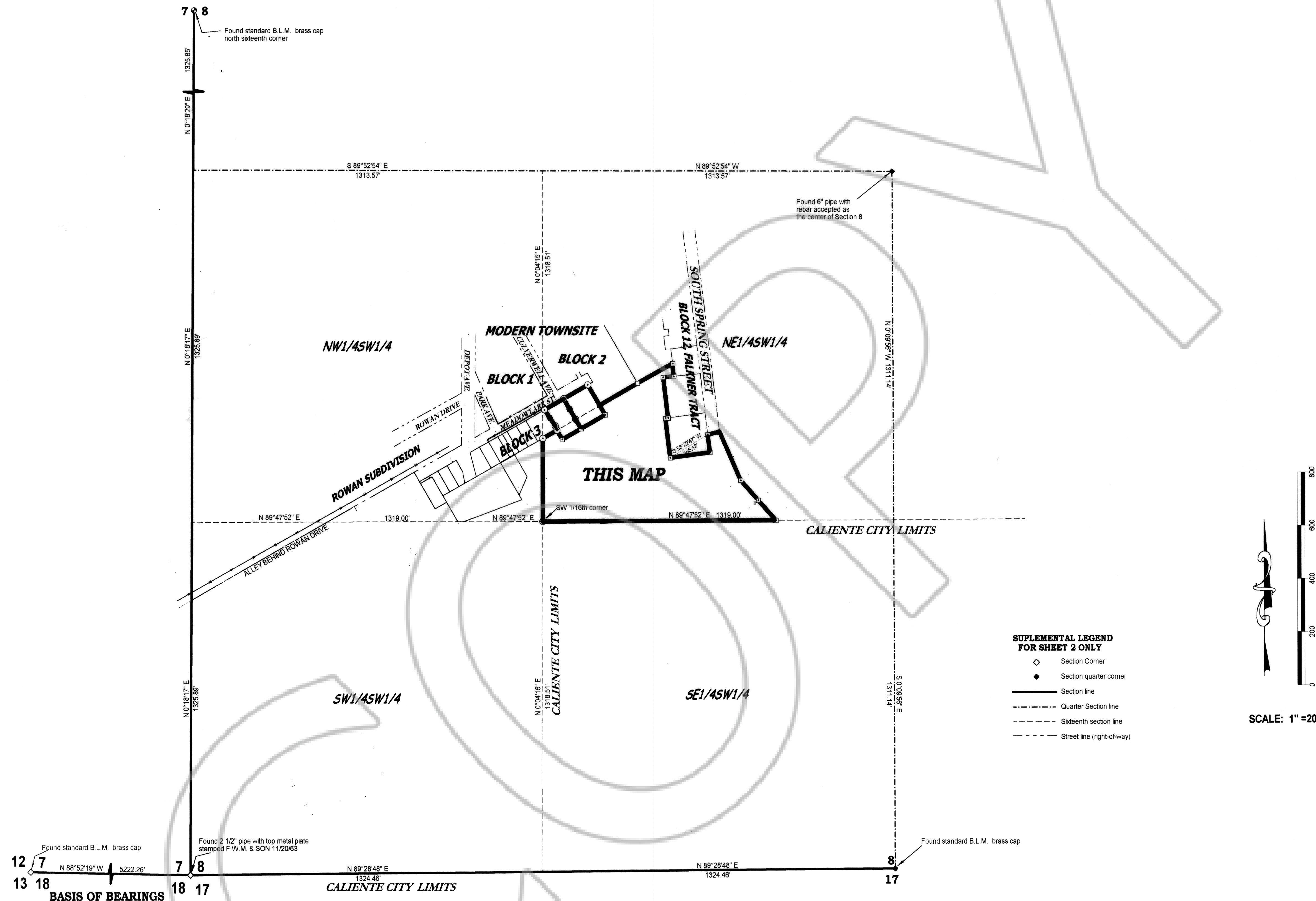

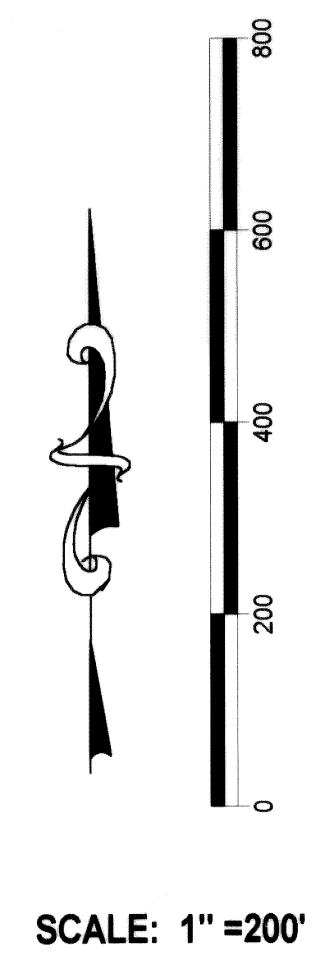
