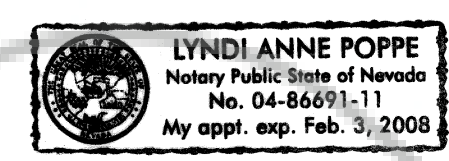

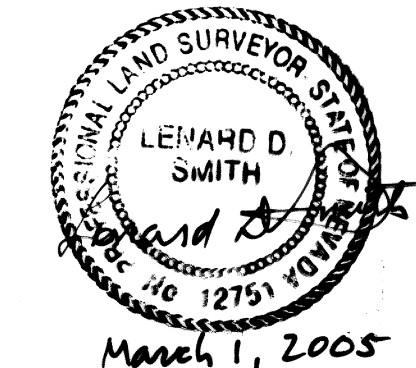

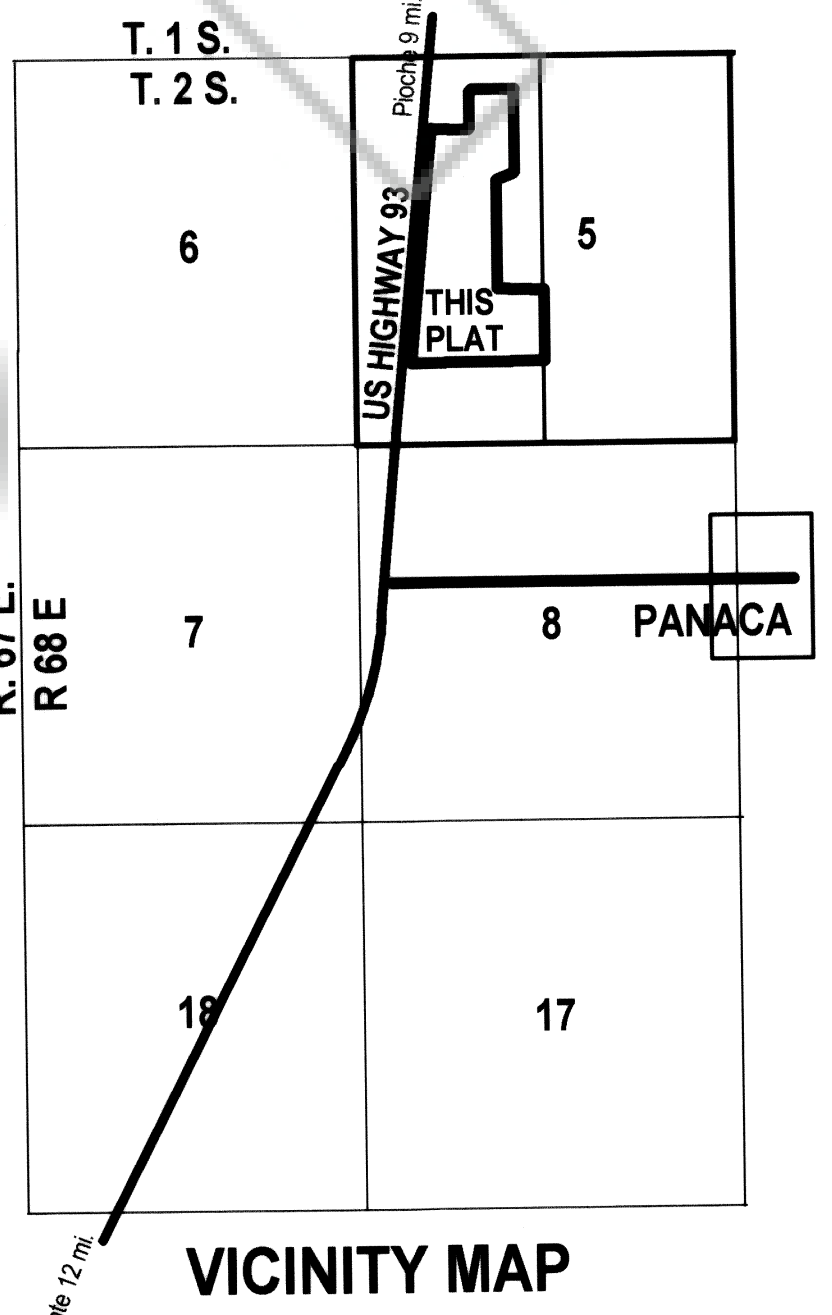
SURVEYOR'S CERTIFICATE

 4. The monuments depicted on the plat are of the character shown, occupy the positions indicated and are of sufficient number and durability.



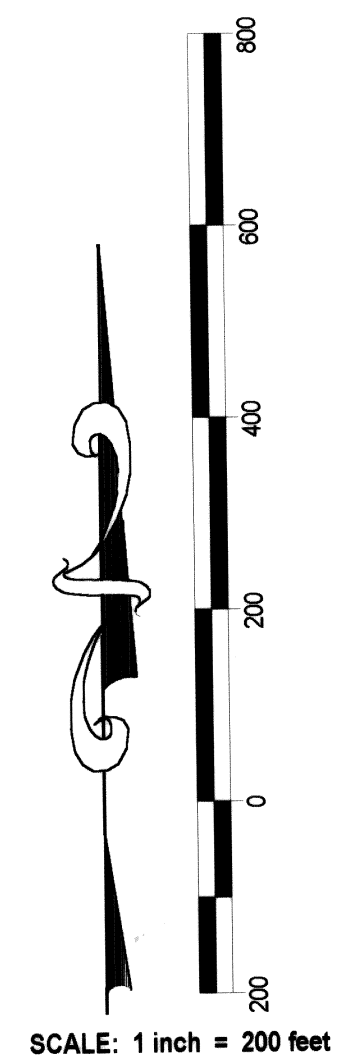
