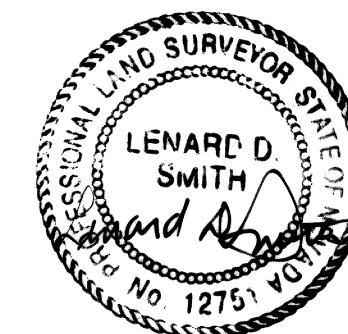


SURVEYOR'S CERTIFICATE

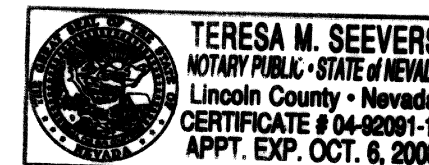

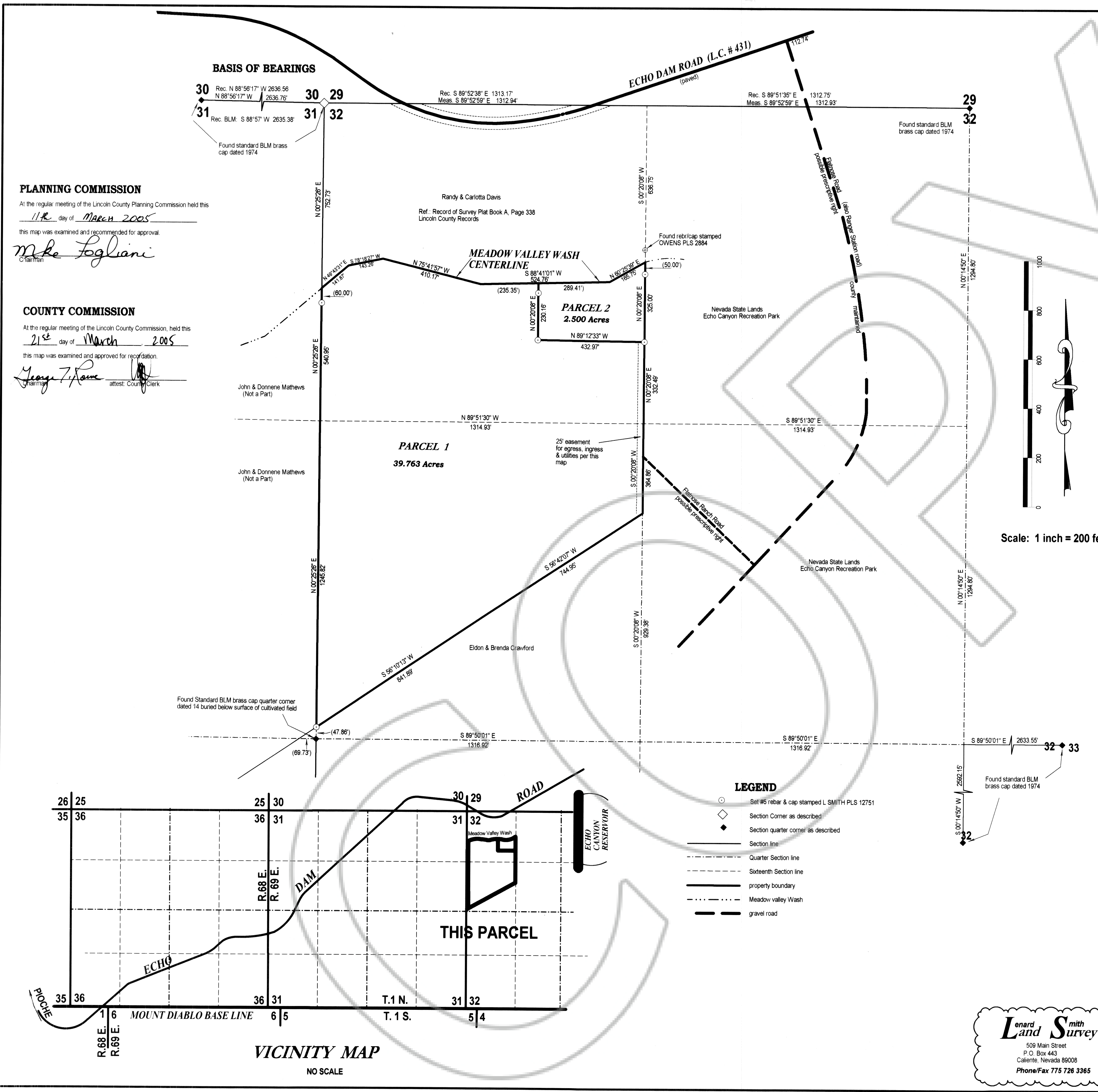

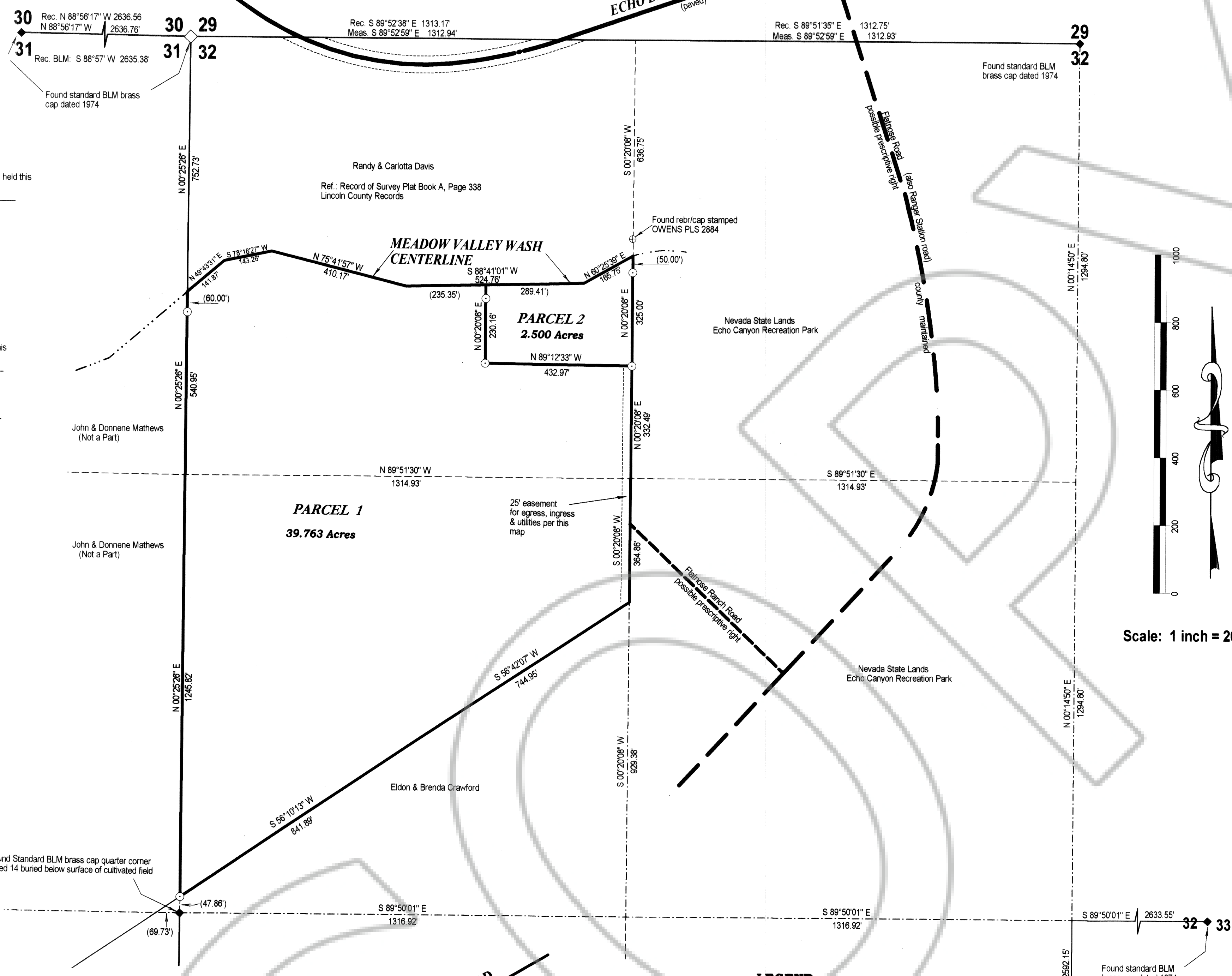
PARCEL MAP

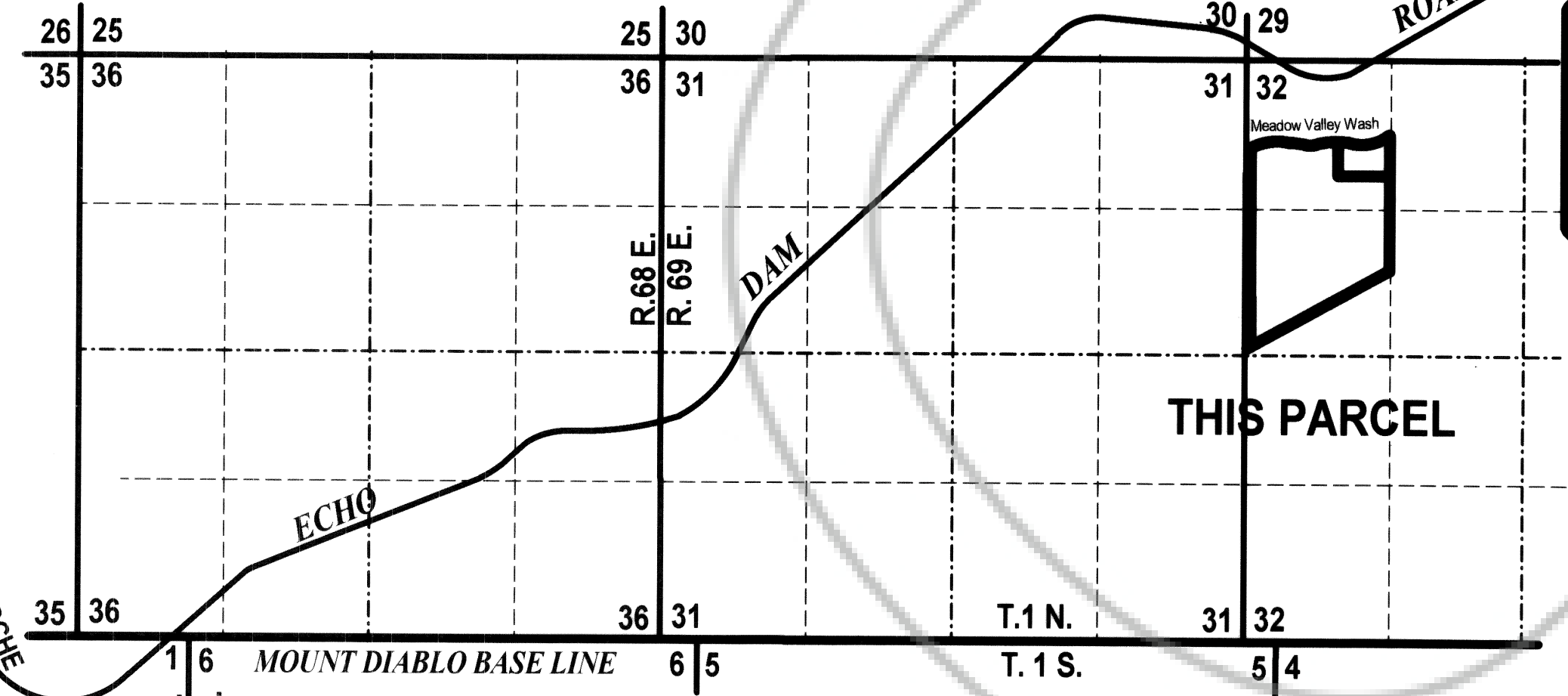
