BASIS OF BEARINGS

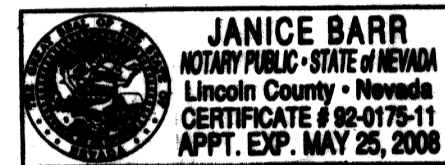

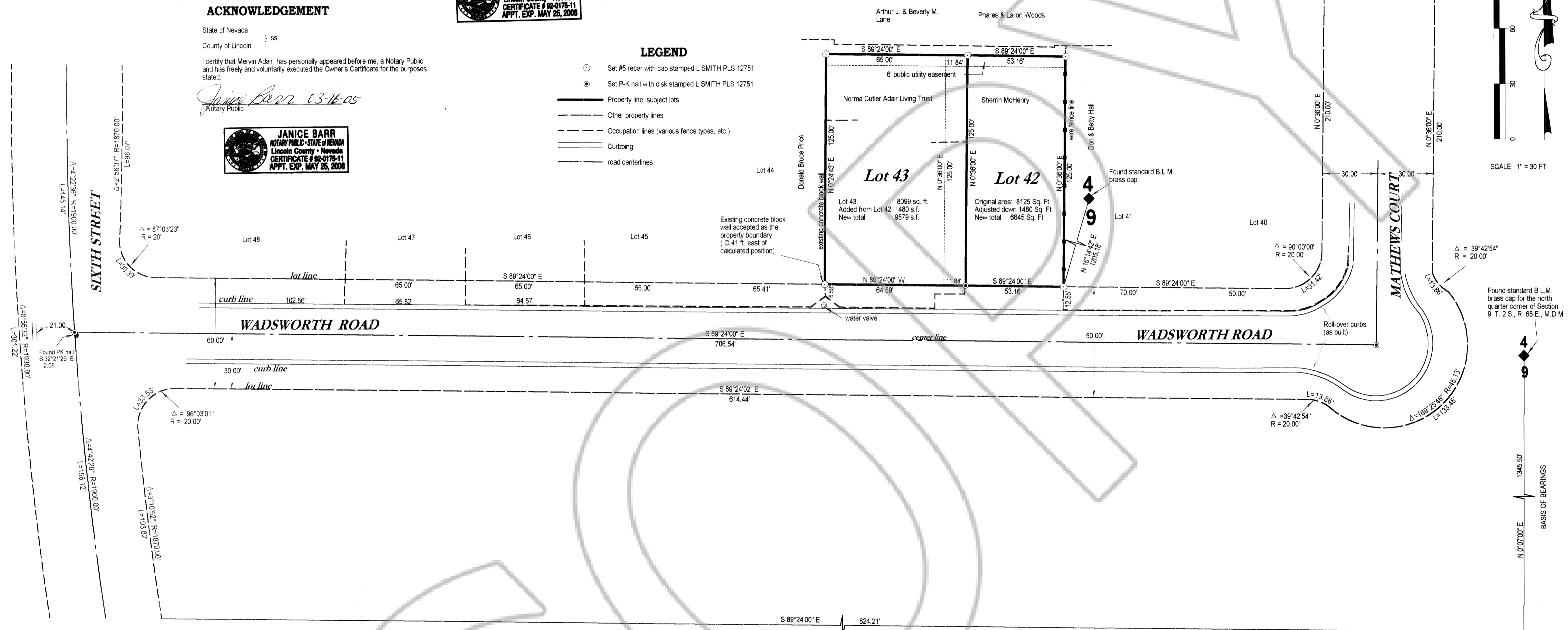

DESCRIPTION OF THE AREA OF THE BOUNDARY ADJUSTMENT

An adjustment of the boundary which adds the following described area of Lot 42 to Lot 43 in the Sun Gold Manor Subdivision in the Town of Panaca, Lincoln County, Nevada in the northwest quarter of Section 9, Township Two South, Range Sixty Eight East of the Mount Diablo Meridian, the area of which is particularly described as follows:

Beginning at the southeast corner of the area to be added to Lot 43, which point is marked by a P-K nail with metal disc stamped L SMITH PLS 12751 and from which point the north quarter corner of said Section 9 bears N 18°38'55" E 1220.59'; Thence N 89°24'00" W 11.84'; Thence N 0°36'00" E 125.00'; Thence S 89°24'00" E 11.84' to a #5 rebar & cap stamped L SMITH PLS 12751; Thence S 00°38'00" W 125.00' to the point of beginning. Containing 1480 square feet more or less.

Excepting therefrom a 6 ft. Panaca Public Utility easement on the north end of the area.

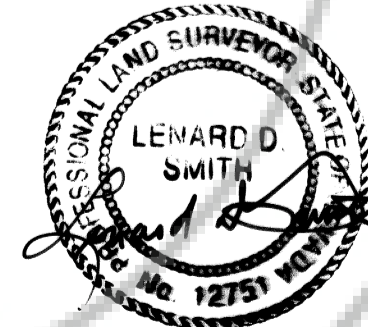
The basis of bearings is the east line of the Sun Gold Manor Subdivision, which is given as S 00°07' W.
