AMENDMENT TO DEED OF TRUST WITH ASSIGNMENT OF RENTS

Each counterpart shall be deemed an original and all counterparts shall be deemed the same instrument with the same effect as if all parties hereto had signed the same signature page. - 4. This Amendment shall be governed by, and construed and enforced in accordance with, the Laws of the State of Nevada.
- 5. Trustor shall pay all expenses, charges, costs and fees incurred in connection with this Amendment, including all fees, charges, and taxes in connection with the recording or filing of this Amendment.
