IT IS HEREBY ORDERED that on five (5) counts, the defendant is sentenced
as follows:

Jail: 6 months for each count—all but 30 days to be suspended upon
the enrollment and completion of an educational course on the
“Care and Feeding of Horses,” to be approved by the Court.
(Credit for 14 days served— Minimum to serve 196 days)

Community: 48 hrs for each count (Total 240 hrs)
Service

Fine: \$1,000 plus \$105.00 Administrative Assessment Fee per count
(Total \$5,525.00) To be paid in monthly installments of \$100.00

IT IS HEREBY ORDERED that the on the remaining thirty (30) counts, the
defendant is sentenced as follows:

Jail: 2 days in jail per count (Total 60 days)

Community : 100 hours per count (Total 3000 hrs)
Service

Fine: \$500.00 plus \$105.00 administrative assessment fee, per count (Total
\$18,150.00) To be paid in monthly installments per agreement in
file.
