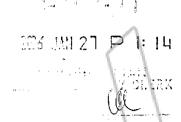

1. That Plaintiff owns in fee simple and is entitled to the quiet and peaceful possession of that certain parcel of land situated in the County of Lincoln, State of Nevada, and more particularly described as follows:

## PARCEL 1:

Commencing at the Southwest (SW) corner of the Northeast Quarter (N1/4) of the Southwest Quarter (SW1/4) of Section 5, Township 7 South, Range 61 East, M.D.B.&M., thence running due East along the South line of said Northeast Quarter (NE1/4) of Southwest Quarter (SW1/4) a distance of 910 feet more or less to the West line of Maine Street at the Northeast (NE) corner of Lot 1, Block 46, Alamo Townsite on file in the Office of the County Recorder of said Lincoln County; running thence North 1°23' West along the West side of Main Street and the projection thereof a distance of 685 feet, thence South 88°37' West a distance of 200 feet, to the true point of beginning; thence North 1°23' West a distance of 218.78 feet, thence due West a distance of 100 feet, thence South 1°23' East a distance of 220.67 feet, thence North 88°37' East a distance of 100 feet to the point of beginning.

## PARCEL 2:

A non-exclusive easement 45 feet wide for a roadway and utilities, the center line of which is described as follows: Commencing at a point in the West line of said Main Street and the projection thereof a distance of 662.50 feet bearing North 1°23' West from said Northeast (NE) corner of Lot 1, Block 46; running thence South 88°37' West a distance of 300 feet to the point of ending.

2. That Plaintiff's title to said real property is hereby forever quieted against any and all claims of Defendants, and all other persons unknown claiming any right, title, estate, lien or interest in the real property;
