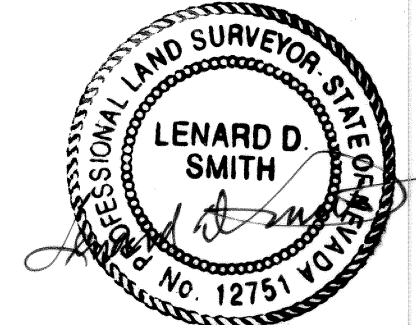


**SURVEYOR'S CERTIFICATE**

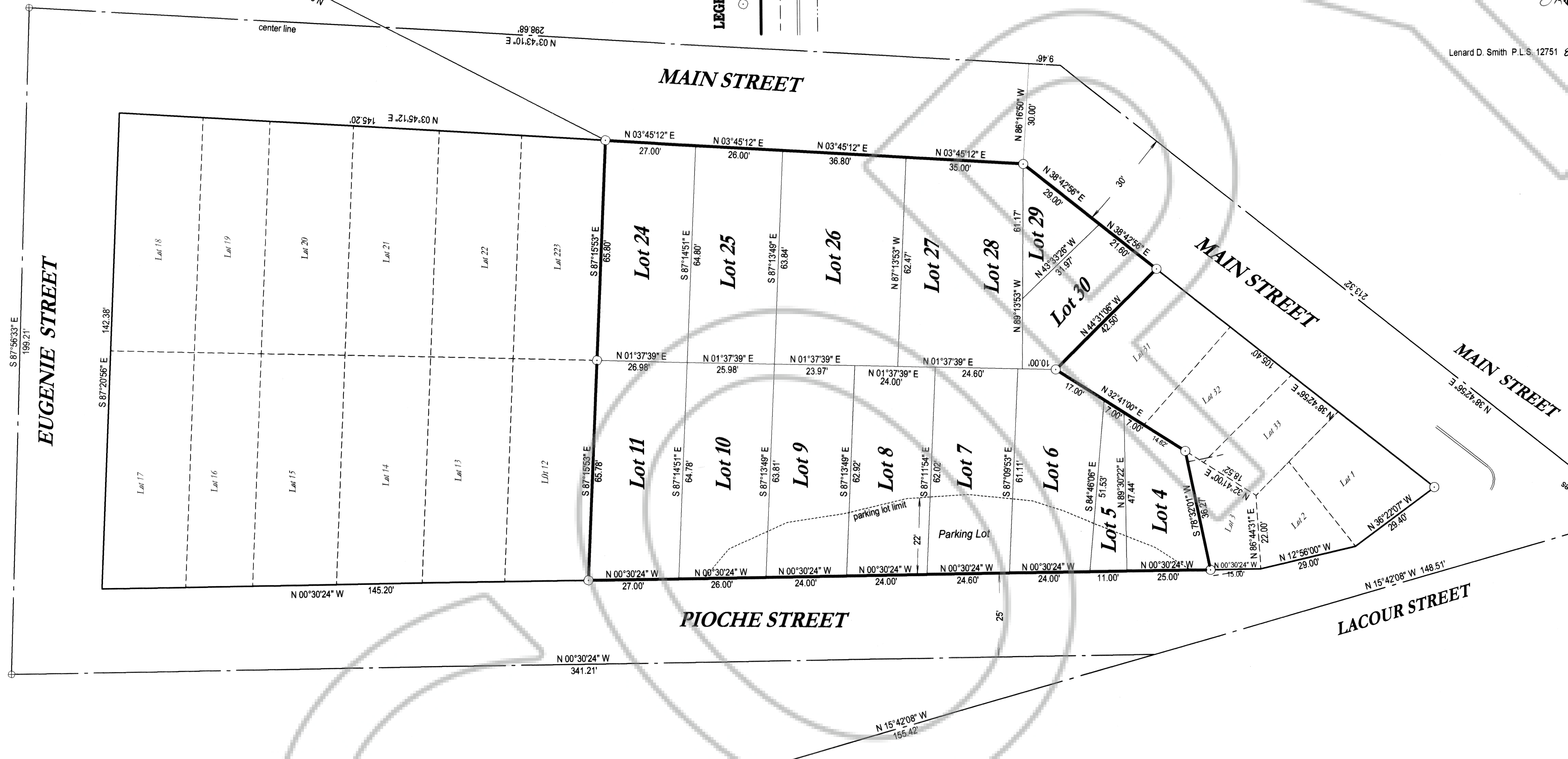

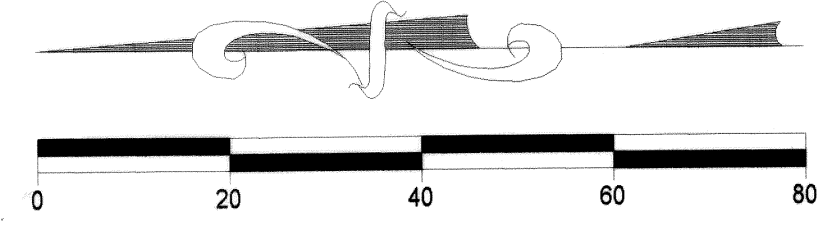


**MAP REFERENCES AND NOTES**
