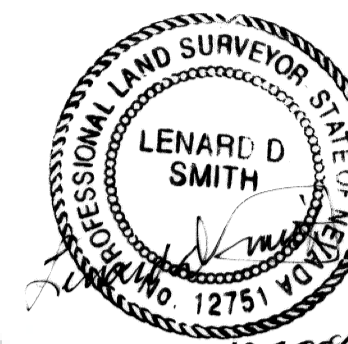


SURVEYOR'S CERTIFICATE

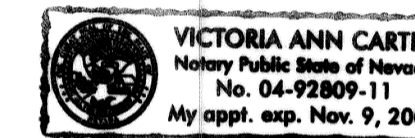

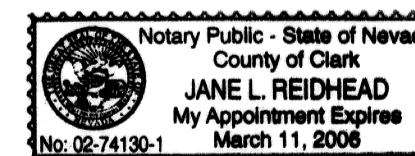

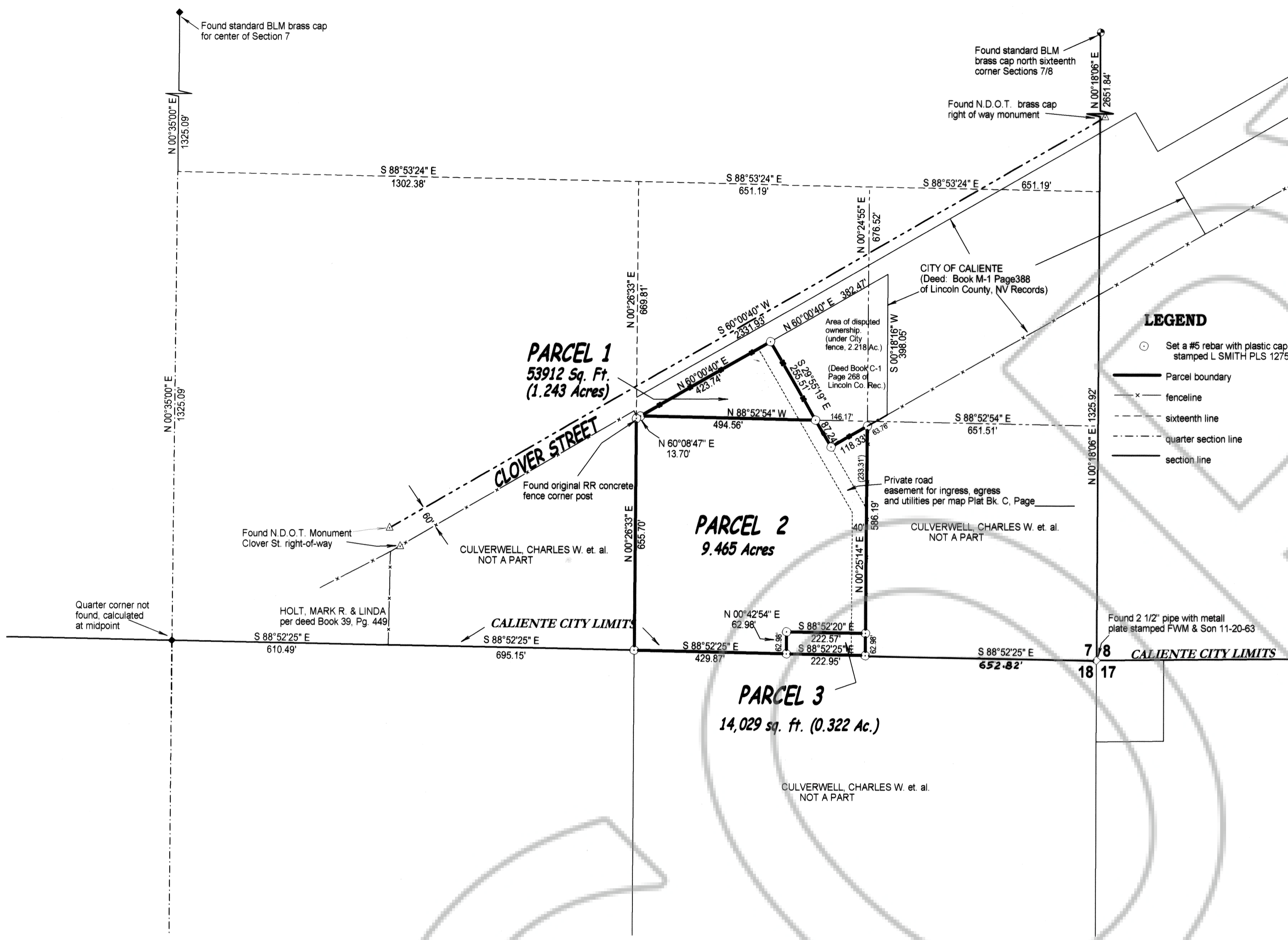

R. 67 E., M.D.M.**

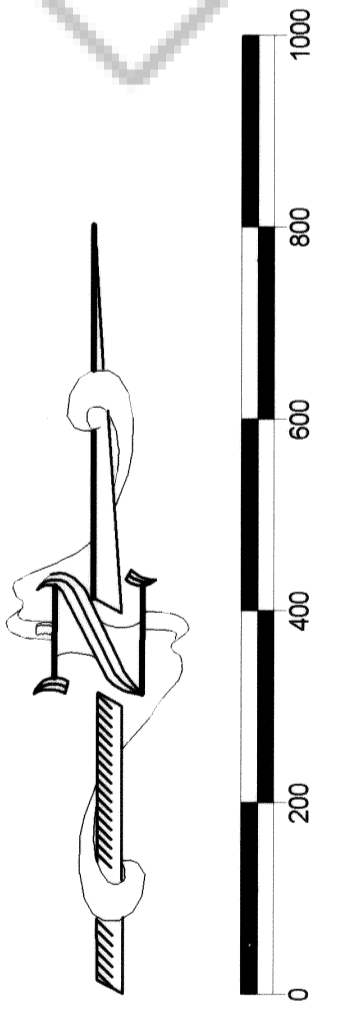
