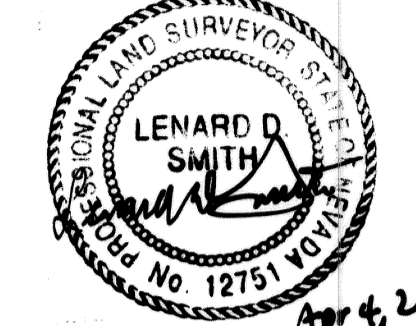

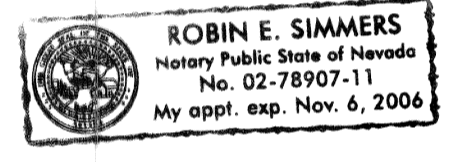

MAP NOTE

This property (and others in this vicinity) were originally laid out as aliquot parts of Section 5, however the stakes found were generally about a foot west of those positions. The owners state that the rebar called for on the map were never set, but the found iron stakes were accepted as property corners. The monuments found east of this property apparently followed the aliquot division of the section.

BASIS OF BEARINGS

The basis of bearings is the south line of Parcels 15-1 through 15-3 of the Parcel Map Plat Book A, Page 255 of Lincoln County Records, given as S 89°34'26" W.
