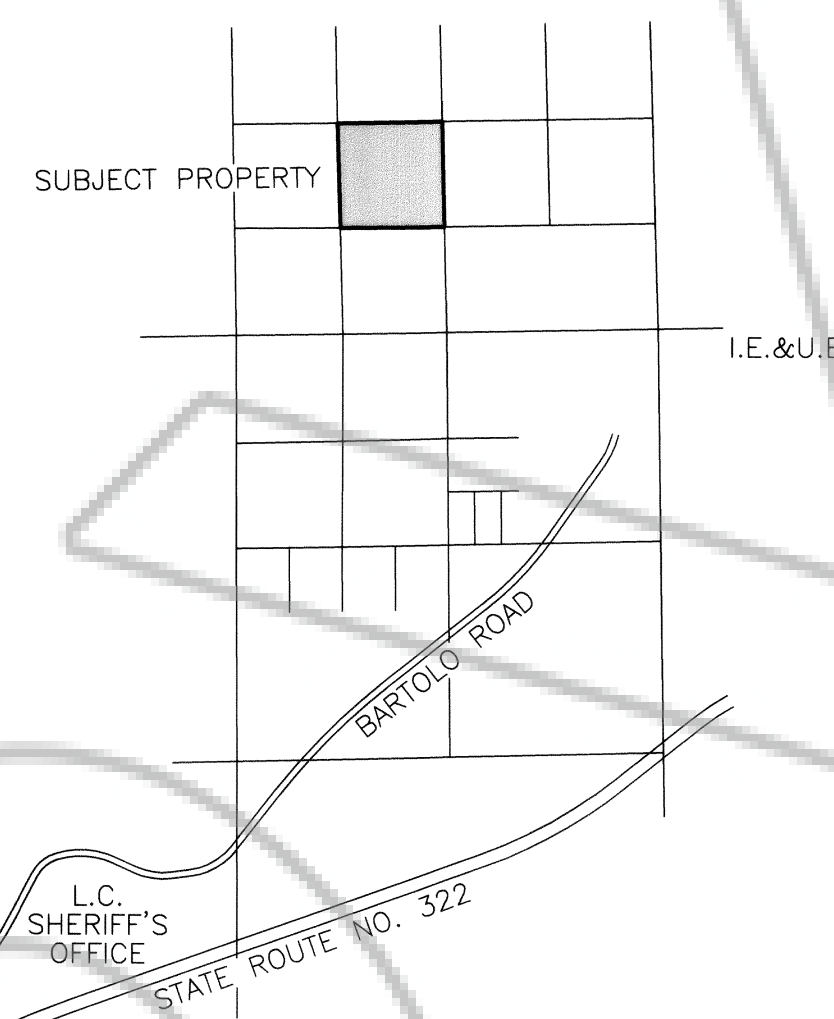


# PARCEL MAP

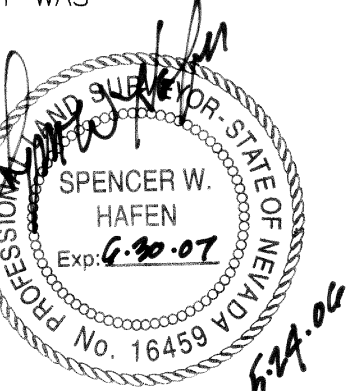
SITUATED WITHIN THE NE1/4 SW1/4 SE1/4 OF SEC. 11

## BASIS OF BEARING

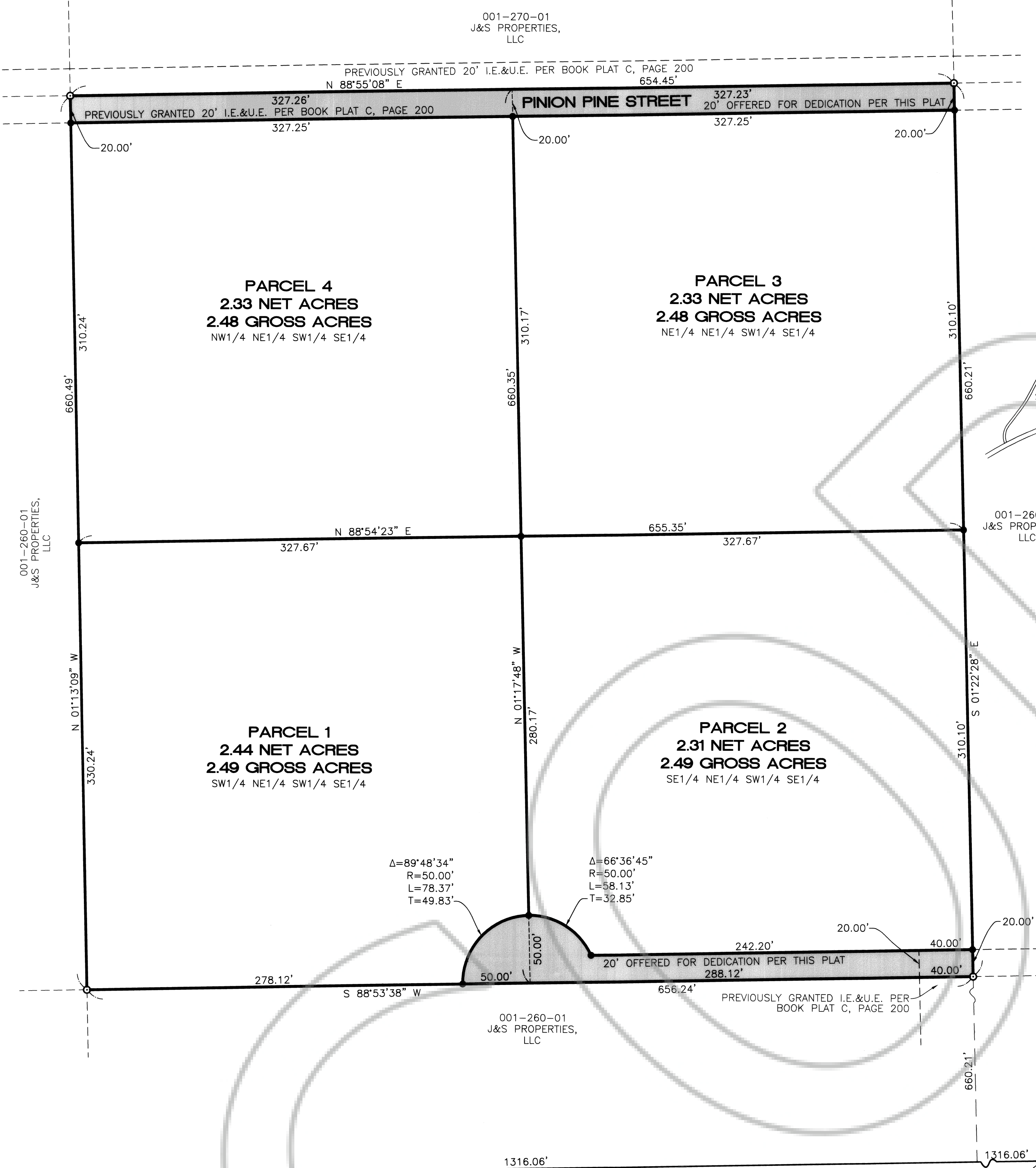

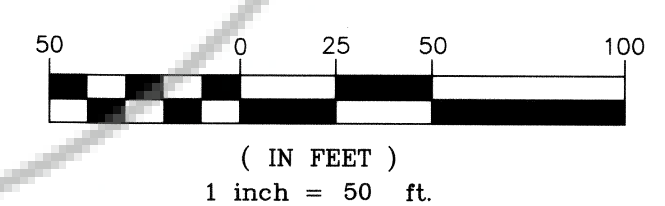



## STATEMENT
