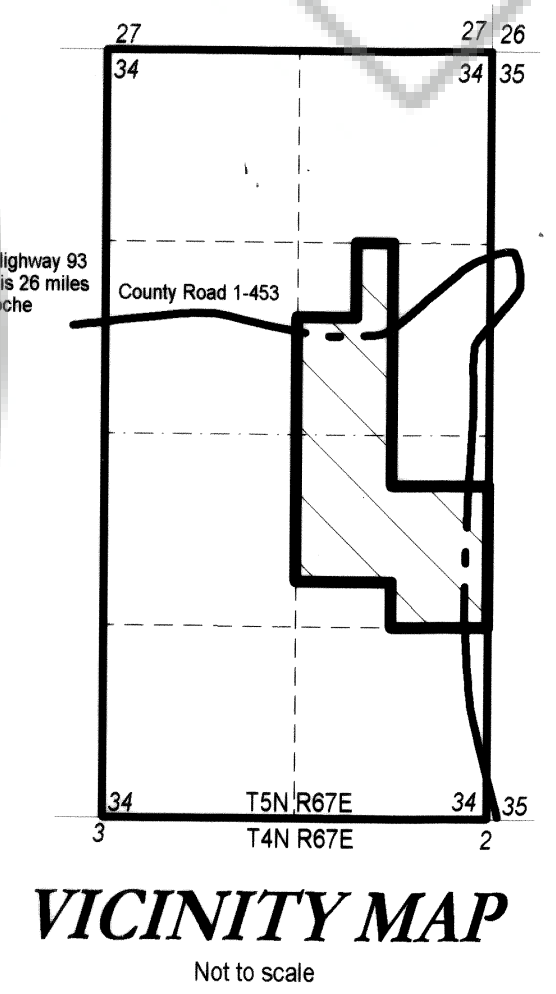
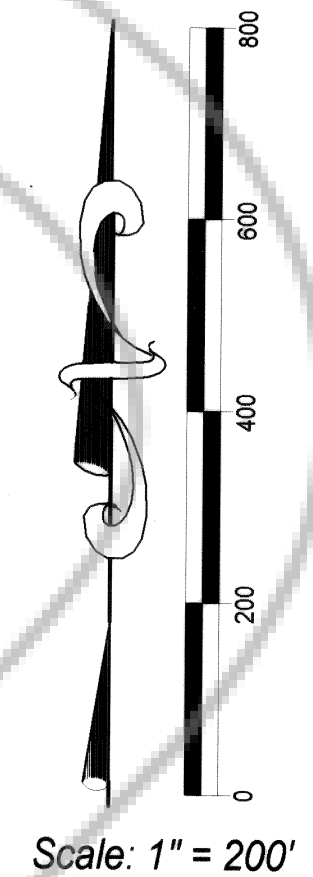


BASIS OF BEARINGS

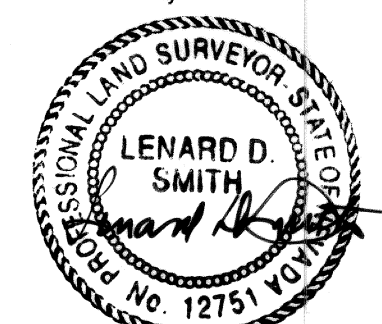

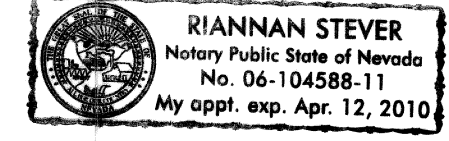

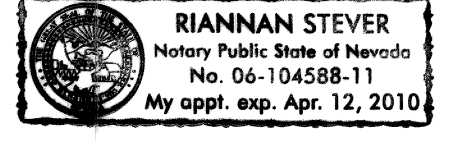
