The Claim is approximately **1500** feet long and **600** feet wide, such that **5** feet are claimed in a **N81°5'31"E** direction and **1495** feet in the opposite direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with **300** feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the **NORTHEAST** to the **SOUTHWEST** direction.
