The Claim is approximately **1500** feet long and **600** feet wide, such that **5** feet are claimed in a **S81°5'31"W** direction and **1495** feet in the opposite direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with **300** feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the **NORTHEAST** to the **SOUTHWEST** direction.

The Discovery Monument upon which a Notice of Location is POSTED, is situate about 5.655 feet SOUTH and 453 feet WEST from the USMM No. 326 which is located approximately 4,500 feet NORTH and 1,020 feet EAST of the SW Corner of Section 31 Township 3 South, Range 57 East, Mount Diablo Base & Meridian.
