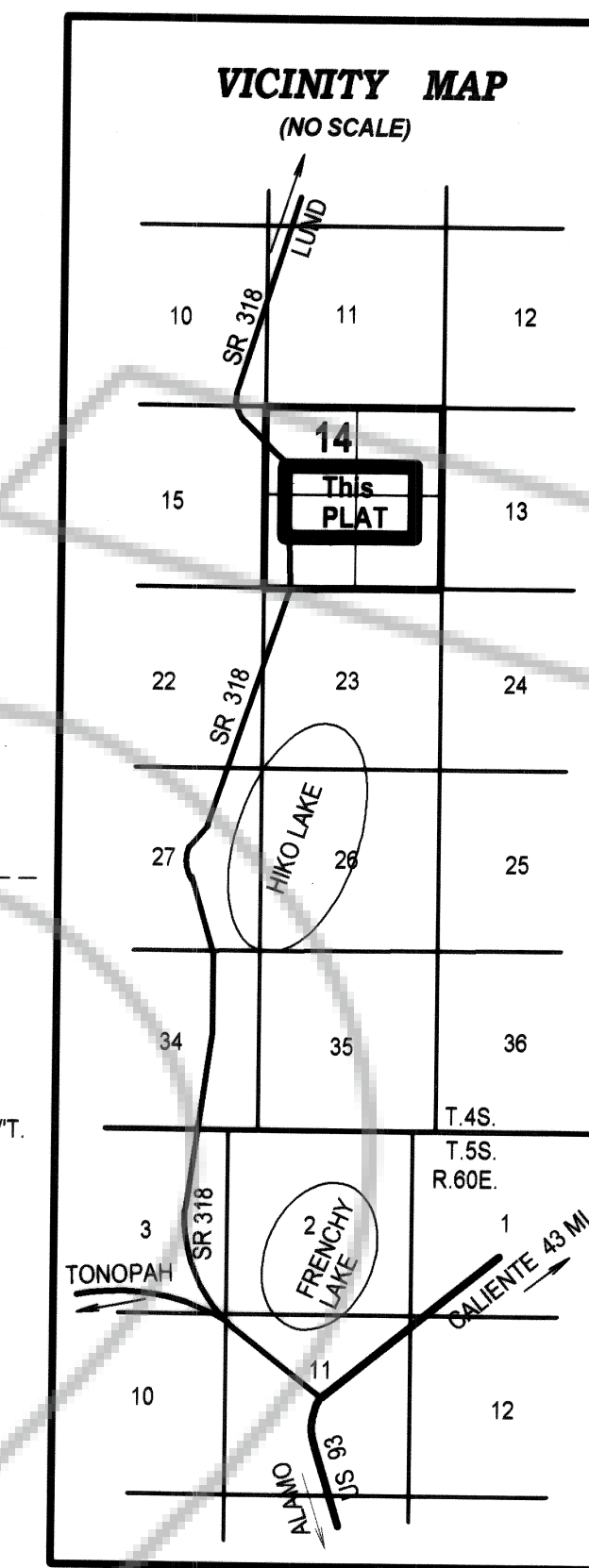

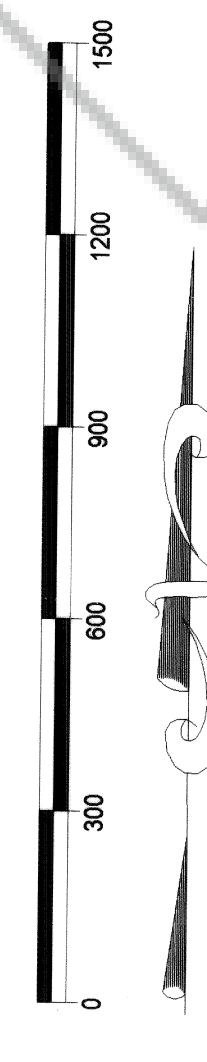

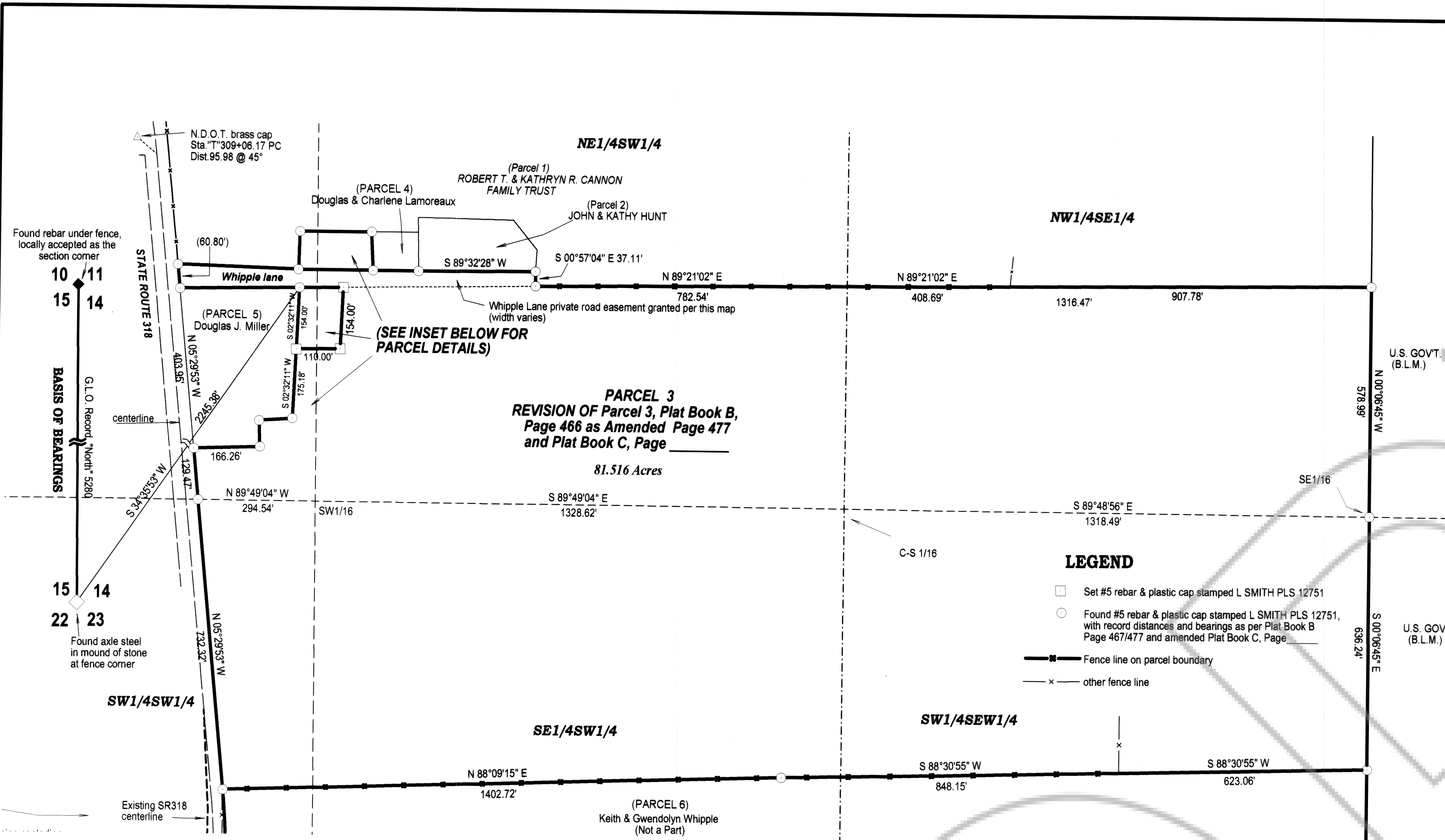
The West line of the southwest quarter of Section 14 given as North in the General Land Office Survey.
