19 **ORDER**

20 The above-entitled matter having come on for hearing before the Honorable Judge  
21 Sandra L. Pomrenze on January 21, 2005. Defendant appeared and was represented by  
22 Matthew D. Carling, Esq. Plaintiff appeared and was represented by Rulon J. Huntsman, Esq.

23 Based upon the arguments of the parties, the evidence adduced at the hearing, and upon  
24 all of the papers and pleadings on file herein:

25 **THE COURT FINDS** Plaintiff, TIMOTHY E. WOOLEVER in contempt for failure to  
26 pay spousal support and is in defiance of the Divorce Decree.

27 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that spousal support  
28 arrearages as of today's date total \$17,856.00 are hereby **REDUCED TO JUDGMENT**. The

1 Court will stay penalties and interest providing Plaintiff starts making up the arrears in  
2 payments of \$100.00 per week until paid in full.

3 **IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that spousal support  
4 shall continue at \$250.00/week plus an additional \$100.00/week.  
5

6 **IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that the Plaintiff sign  
7 the Bill of Sale for the marital property which was signed in open court and notarized by the  
8 Court's administrative assistant.

9 **IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that Defendant is  
10 awarded ATTORNEY FEES in the amount of \$500.00 which are hereby REDUCED TO  
11 JUDGMENT.

13 **IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that arrears and  
14 attorney fees have both been reduced to judgment. Counsel for the Defendant may seek other  
15 enforcement measures if necessary.


