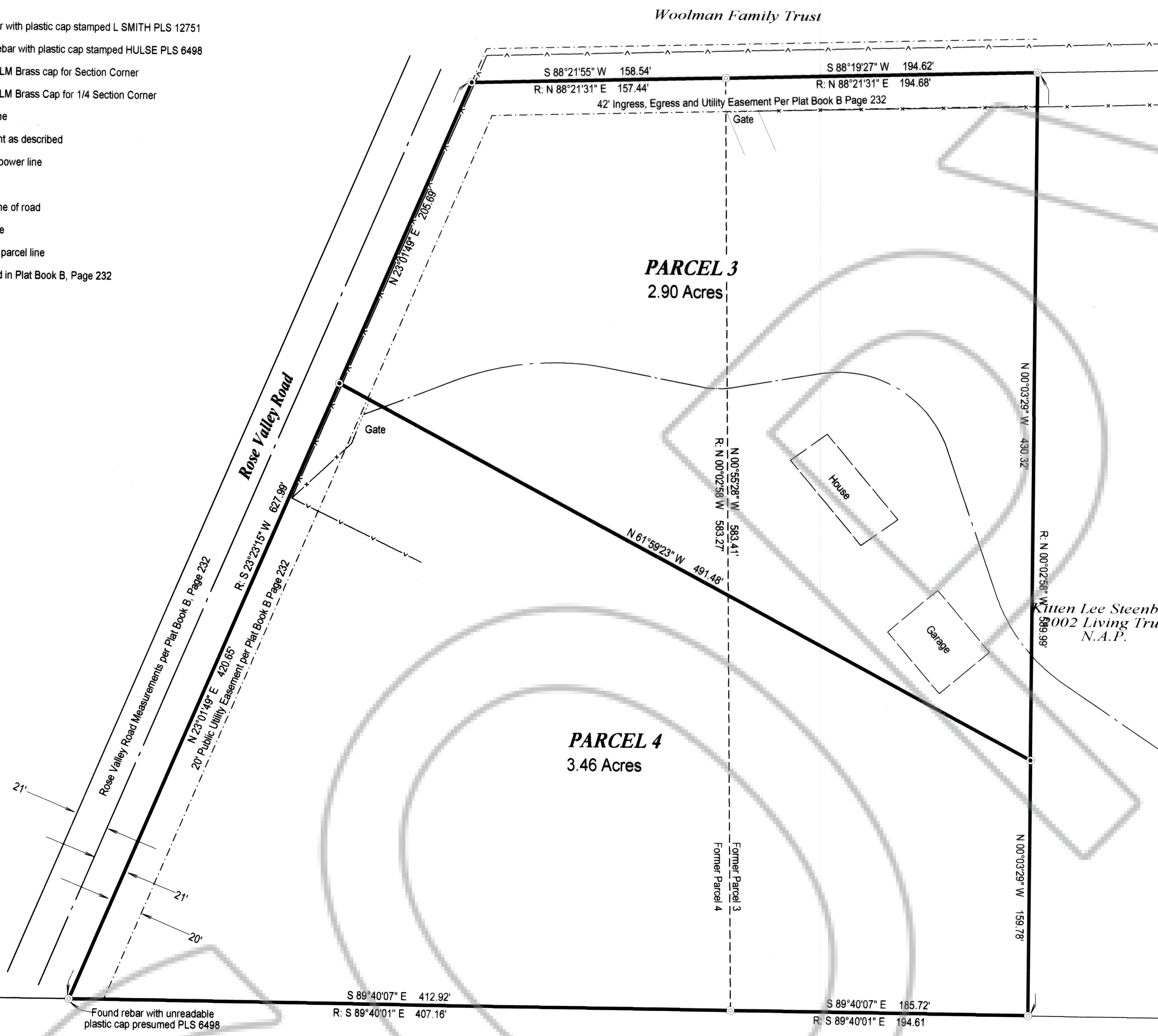

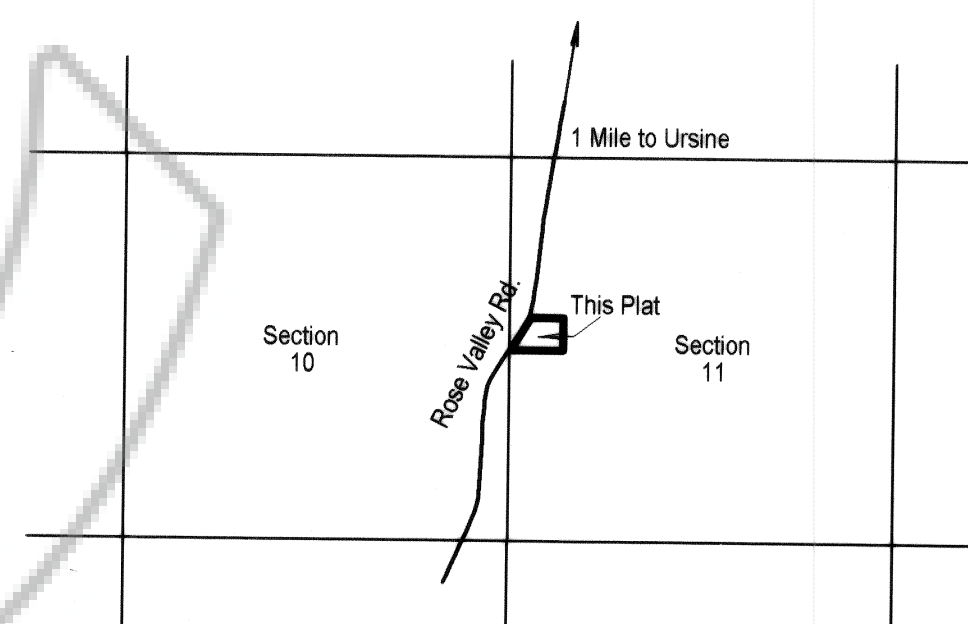

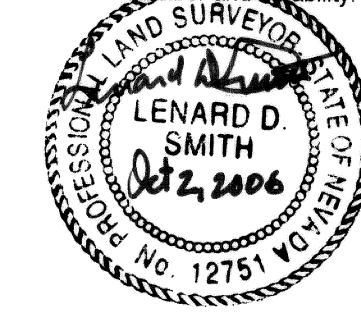
VICINITY MAP

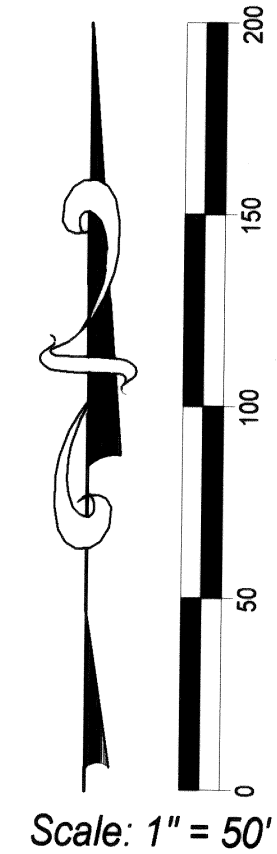
