 18 Upon the Stipulation for Judgment executed by the parties hereto, Plaintiff, CAPITAL
 19 ONE BANK ("Plaintiff"), by and through its attorney, JEFFREY G. SLOANE, ESQ., of the
 20 firm of KRAVITZ SCHNITZER SLOANE JOHNSON & EBERHARDY, and the Defendants,
 21 WENDY L KIRCHESH ("Defendants") that the Plaintiff has Judgment against said
 22 defendants for the sum of \$2,001.96, together with interest at the rate of 21.15 percent per annum
 23 from November 29, 2002, plus attorneys fees in the amount of \$677.00 and court costs of
 24 \$50.00, and all costs accrued after judgment.

26 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Plaintiff have
 27 Judgment against said Defendants for the sum of \$2,001.96, together with interest at the rate of
 28 21.15 percent per annum from November 29, 2002, plus attorneys fees in the amount of \$677.00



1 and court costs of \$50.00, and all costs accrued after judgment.

2 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the aforementioned
3 Judgment shall be paid as follows:

4 Beginning on or before the TWENTY-FIFTH (25TH) day of JULY, 2006, Defendants
5 shall pay Plaintiff ONE HUNDRED SEVENTY-FIVE AND 00/100 Dollars, (\$175.00), per
6 month, and a like amount on or before the TWENTY-FIFTH (25TH) day of each month
7 thereafter until the full amount of the Judgment has been extinguished.

9 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that payments shall be
10 made payable to "KSSJE" and delivered or mailed to the offices of KRAVITZ SCHNITZER
11 SLOANE JOHNSON & EBERHARDY, Attention: Payments, 1389 Galleria Drive, Suite 200,
12 Henderson, NV 89014 and shall be received by said offices on or before the aforementioned
13 dates, referencing Account 4388641773567958 on all payments.

15 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that in the event the
16 Defendants fail, neglect or refuse to pay any such payment on or before its due date, then all
17 sums remaining due under such Judgment shall become due and owing and entry and execution
18 may thereupon issue without benefit of notice to the Defendants.

20 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that upon payment in full
21 of the amounts aforementioned in the manner provided for herein, Plaintiff shall file a
22 Satisfaction of Judgment.

24 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that upon payment in full
25 of the amounts aforementioned in the manner provided for herein, Plaintiff shall extinguish all
26 lien rights it may have in any property of the Defendants.

27 IT IS FURTHER ORDERED, AJUDGED AND DECREED that pursuant to Nevada
28 Rules of Civil Procedure 41(e) that enforcement of this Judgment may be made by Plaintiff

1 against Defendant at any time in the future should Defendant default on the payments, and that
2 any limitation stated in Nevada Rules of Civil Procedure 41(e) is hereby waived in its entirety by
3 Defendants.
