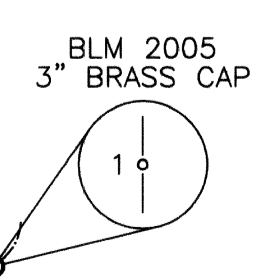
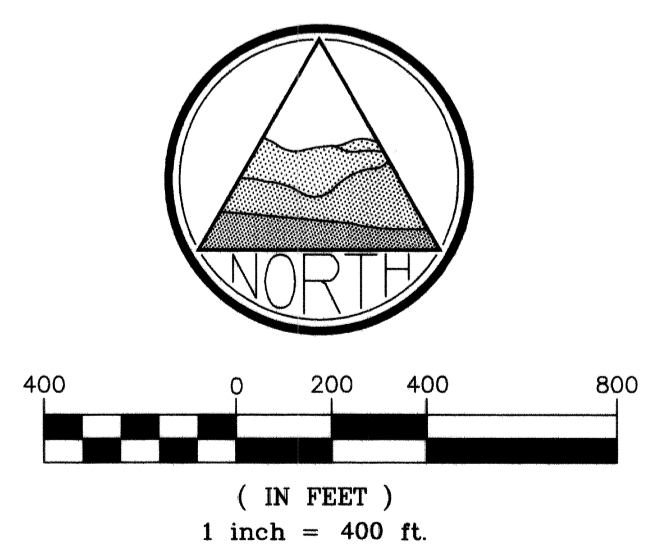
## STATEMENT
