DEED OF TRUST WITH ASSIGNMENTS OF RENTS

THIS DEED OF TRUST, made December 7, 2006, between Paul Coroneos, a married man as his sole and separate property, TRUSTOR, whose address is 440 Jefferson Blvd, Henderson, NV 89011, First American Title Company of Nevada, a Nevada Corporation, TRUSTEE, and Greg F. Johnson and Carletta J. Johnson, husband and wife as joint tenants, BENEFICIARY, whose address is P.O. Box 479, Pioche, NV 89043.

WITNESSETH: That Trustor grants to Trustee in trust, with power of sale, that property in the County of **Lincoln**, State of **Nevada**, described as:

DUE ON SALE
