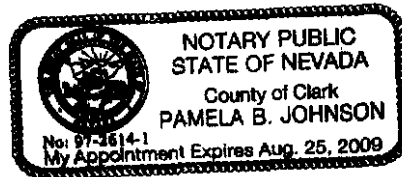

Part of the Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) in Section 10, Township 5 South, Range 60 East, Lincoln County, Nevada, described as follows:
