The Claim is approximately 1450 feet long and 600 feet wide, such that 5 feet are claimed in a NORTH direction and 1445 feet in the opposite direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the NORTH to the SOUTH direction.

The Discovery Monument upon which a Notice of Location is POSTED, is situate about 345 feet NORTH and 3,845 feet WEST from the West ¼ Corner of Section 25 Township 3 South, Range 56 East, Mount Diablo Base & Meridian.
