The Monument of Location upon which a Notice of Location is POSTED, is situate at the Northeast corner of Placer Claim and is located about 1,800 feet NORTH and 5,345 feet WEST from the East ¼ Corner of Section 25 Township 3 South, Range 56 East, Mount Diablo Base & Meridian.

The exterior boundaries of this location are distinctly marked by 1 ½" X 1 ½" wooden posts at each corner and its boundaries can be readily traced by:

Beginning at Corner No. 1, the northeast corner, thence southerly, 1450 feet to Corner No. 2, the southeast corner, thence westerly, 600 feet to Corner No. 3, the southwest corner, thence northerly, 1450 feet to Corner No. 4, the northwest corner, thence easterly, 600 feet to Corner No. 1, the northeast corner, point of beginning.
