Lincoln, State of Nevada, and more particularity described as follows:

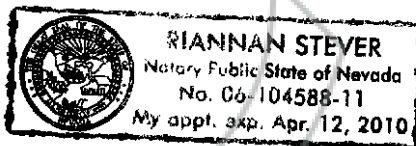
Lots 55, 56, 57, 58, 59, and 60, in the Falkner Plat of the City of Caliente,
