QUITCLAIM DEED

WHEREAS, the DIVISION OF CHILD AND FAMILY SERVICES, as successor in interest to the Nevada Girls Training Center, hereinafter referred to as GRANTOR, is the owner of that certain real property located in Lincoln County, State of Nevada; and

WHEREAS, on May 6, 1974 the Nevada Girls Training Center recorded a deed in Lincoln County for the land described in the deed recorded May 6, 1974, as instrument no. 54293, in Book 10, Page 109, Official Records of Lincoln County, obtained from the City of Caliente; and

WHEREAS, pursuant to NRS 321.001 the NEVADA DIVISION OF STATE LANDS, hereinafter referred to as GRANTEE, is required to acquire and hold in the name of the State of Nevada all lands and interests in land owned or required by the state; and

WHEREAS, the aforementioned land has not been deeded over the Nevada Division of State Lands pursuant to NRS 321.001; and

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, GRANTOR, does hereby REMISE, RELEASE AND FOREVER QUITCLAIM to GRANTEE, all right, title, and interest in and to the real property more particularly described as follows:



The South 30 Feet of Hospital Street, bordering Lot no. 6 and the west 72 feet of Lot no. 4 in Block 49 of the Northside Addition to the City of Caliente, Nevada, being a rectangular piece 30 feet by 440.44 feet and more particularly depicted at page 48, Plats Book "A" as recorded in the office of the County Recorder in Lincoln County, Nevada

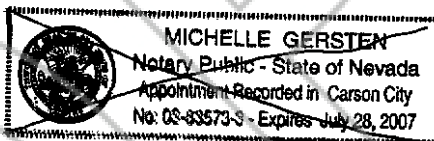
Together with all buildings, improvements and water rights thereon.
