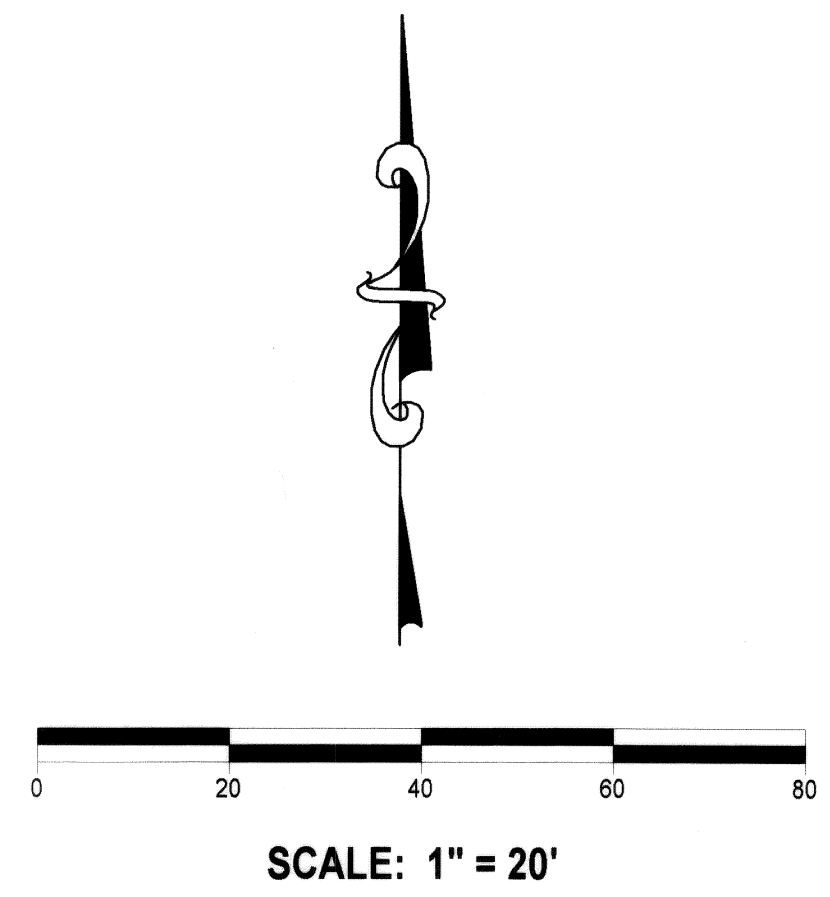
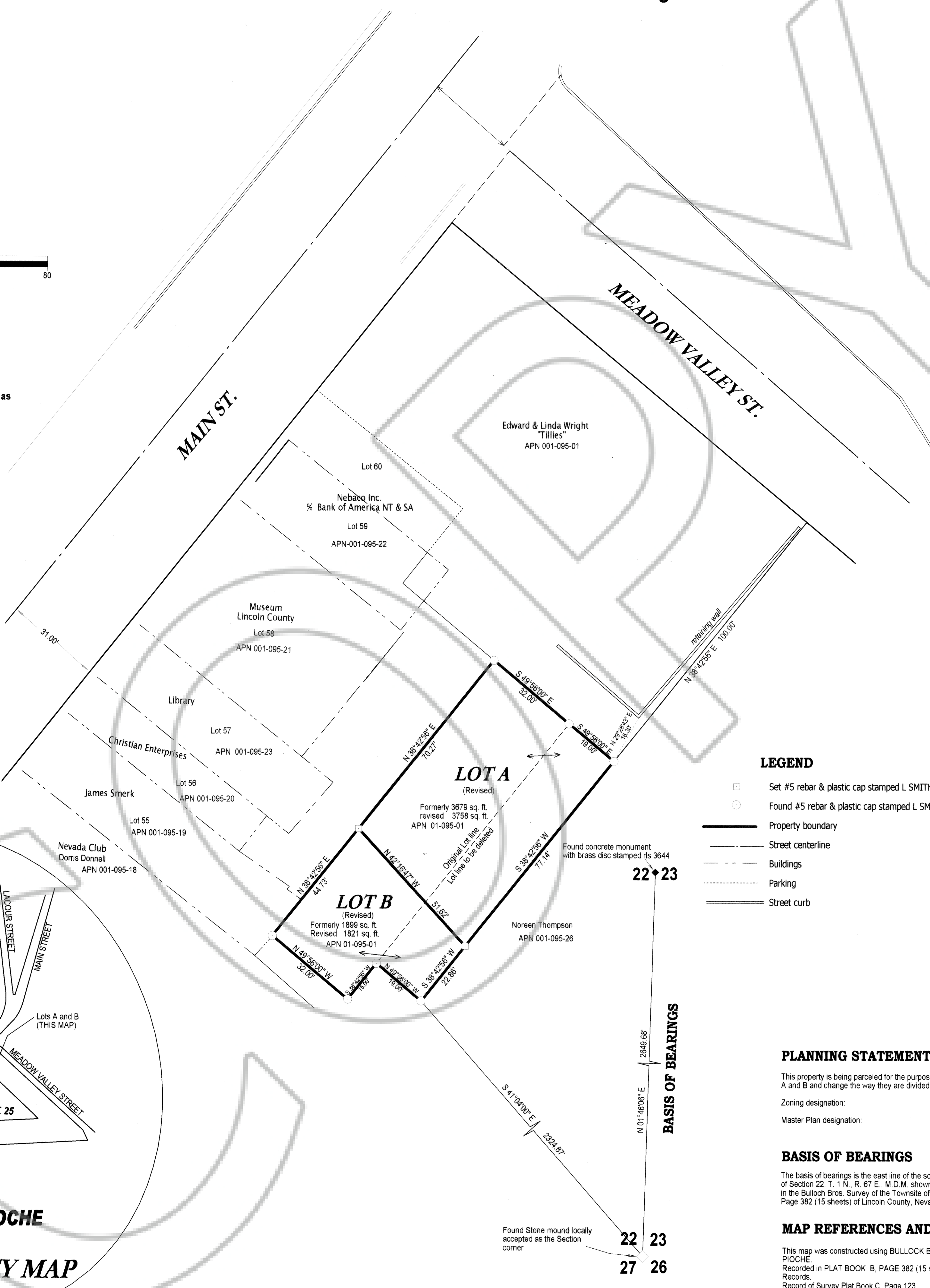
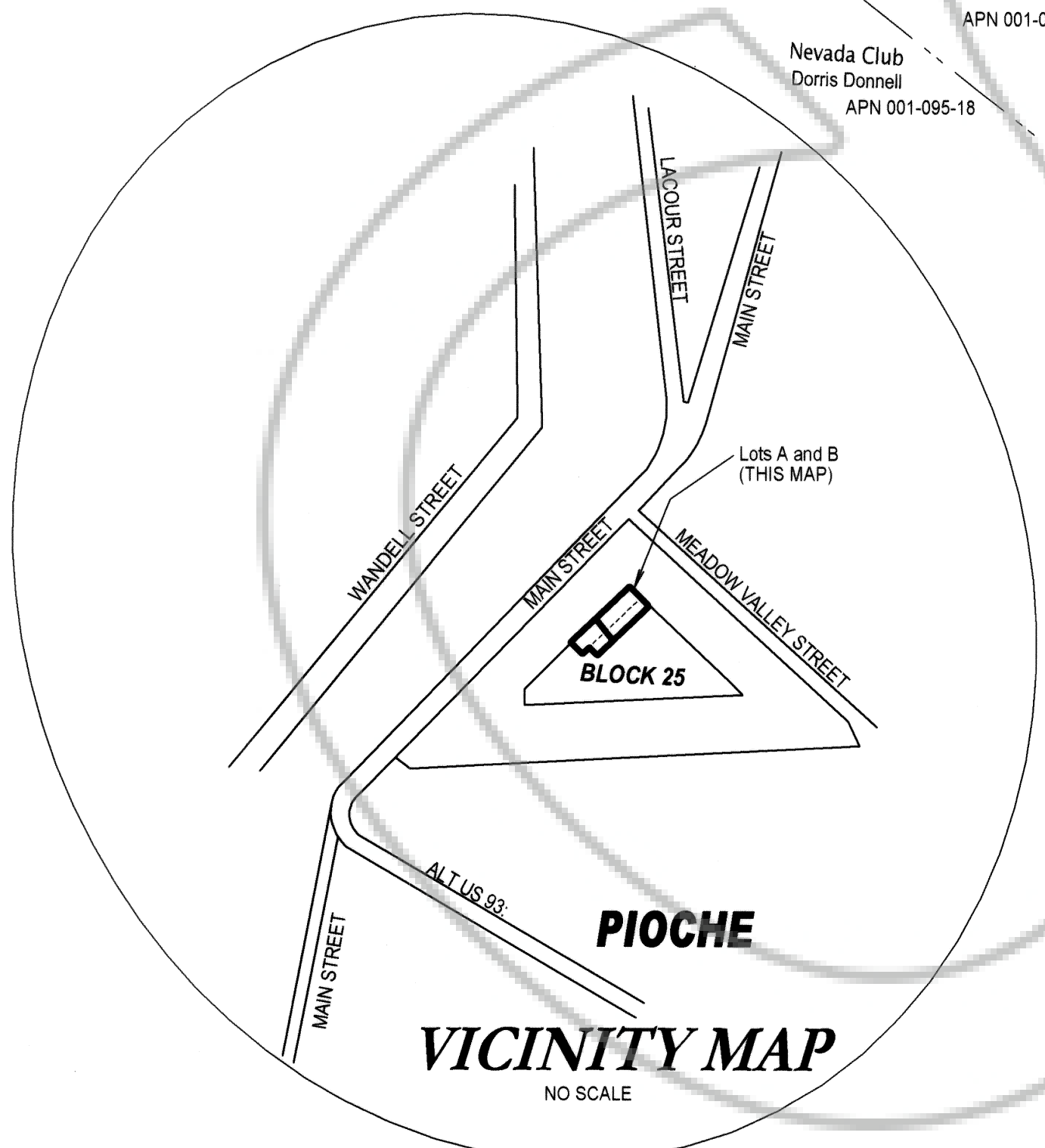


PARCEL MAP- Planning # 07-119-PM-C2-PC

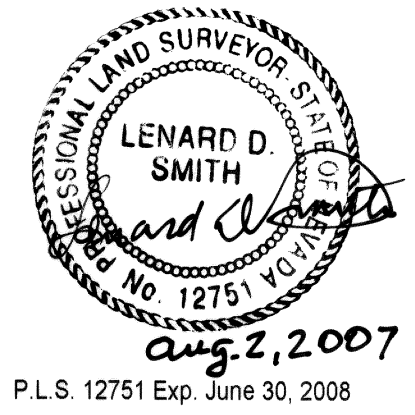

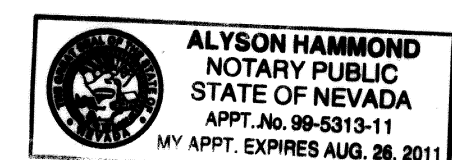
