

17 In this action, Summary Judgment having been entered against the
18 defendant, judgment is hereby entered against said defendant in
19 pursuance to the prayer of said complaint.

20 IT IS ORDERED, ADJUDGED AND DECREED that the Court finds that
21 Defendant MAST ENTERPRISES, INC., a Nevada corporation, admits the
22 allegations of the complaint and statements titled as affirmative
23 defense do not rise to the level of a defense. Service on the
24 defendant was proper.

25 IT IS FURTHER ORDERED, ADJUDGED AND DECREED the said plaintiff
26 shall have and recover from defendant MAST ENTERPRISES, INC. a Nevada
27 corporation, the sum of \$10,826.00, together with 6.75% interest
28 thereon from October 2, 2002, plus costs and disbursements incurred

1 in this action amount to the sum of \$191.33, and a reasonable
2 attorney's fee in the sum of \$ 5000.⁰⁰ (five thousand dollar)
