MEMORANDUM OF AGREEMENT

This is a Memorandum of Replacement Water Rights Purchase Agreement ("Memorandum") entered into as of the 30th day of June, 2008 by and between The Pougot Water and Power Company, LLC, a Nevada limited liability company and Toquop Energy, LLC, a Delaware limited liability company.
