**MEMORANDUM OF MODIFICATION AGREEMENT

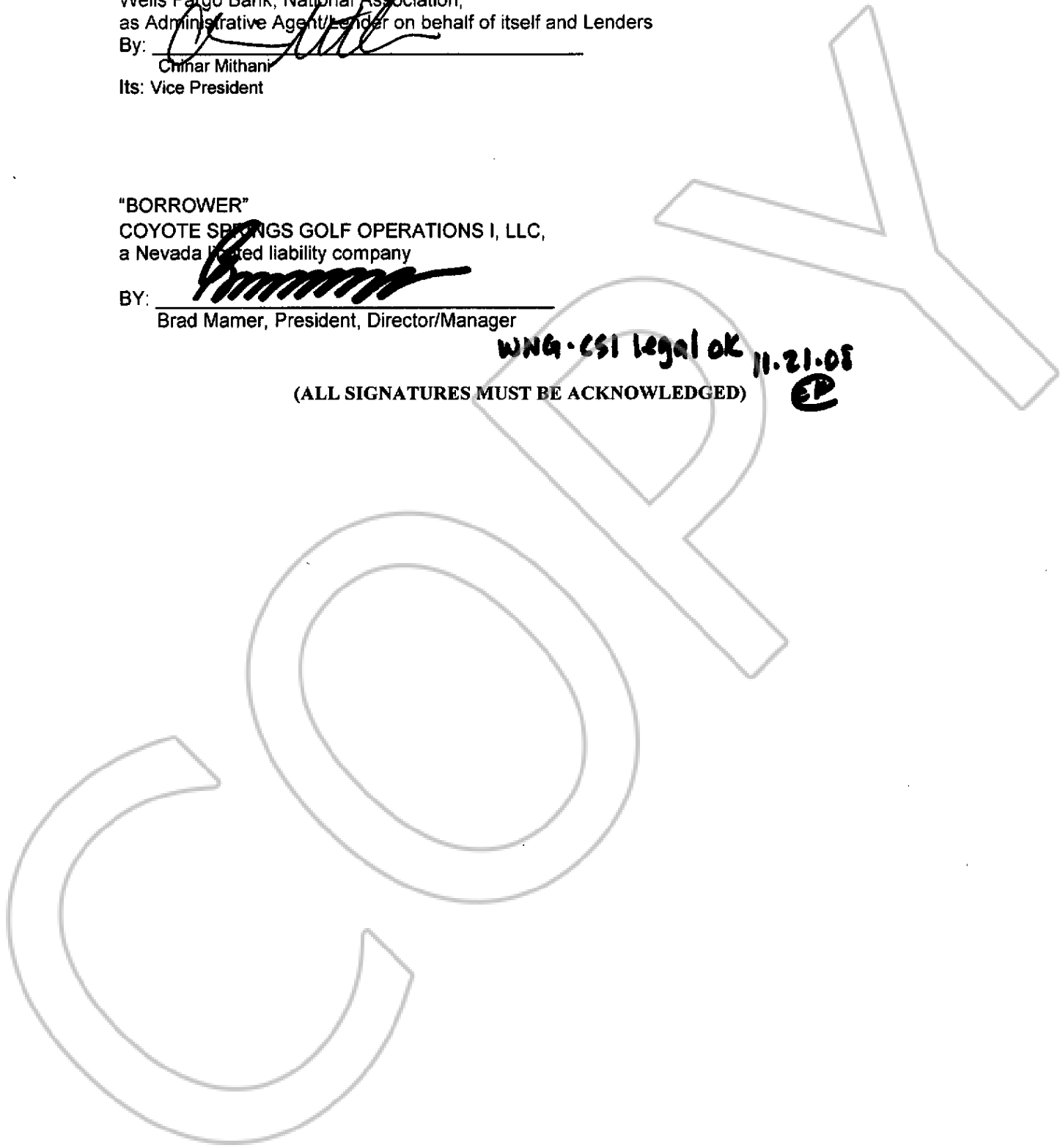

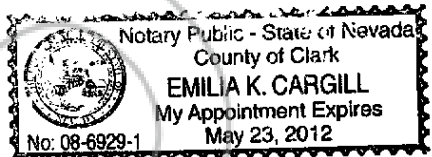
