PROMISSORY NOTE

\$15,000.00

Date: November 1, 2008

For value received, the undersigned Mike and Tiffany Taylor ("the Promisor's") promises to pay to the order of Robert S and Linda S Rollins, ("the Payees"), at #11 Caselton Dr, HC-74, Box 115, Pioche, NV 89043, (or at such other place as the Payee may designate in writing) the sum of \$15,000.00 with interest from November 01, 2008 on the unpaid principal at the rate of 5.0% per annum.

The unpaid principal and accrued interest shall be payable in monthly installments of \$361.84 beginning on December 01, 2008, and continuing until March, 2012, ("the Due Date"), at which time, the remaining unpaid principal or principal and interest shall be due in full. A down payment of \$2,000.00 will be due upon execution of this note and monthly payments shall follow each month as agreed upon. All payments on this NOTE shall be applied first in payment of accrued interest and any remainder in payment of principal.

The Promisor's promises to pay a late charge of \$25.00 for each installment that remains unpaid more than 10 day (s) after its due date. This late charge shall be paid as liquidated damages in lieu of actual damages, and not as a penalty.

If any one or more of the provisions of the Note are determined to be unenforceable, in whole or in part, for any reason, the remaining provisions shall remain fully operative.

All payments of principal and interest on this Note shall be paid in the legal currency of the United States. Promisor's waives presentment for payment, protest, and notice of protest and nonpayment of this Note.

No renewal or extension of this Note, delay in enforcing any right of the Payee under this Note, or assignment by Payee of this Note shall affect the liability of the Promisor's. All rights of the Payee under this Note are cumulative and may be exercised concurrently or consecutively at the Payee's option.

This Note shall be construed in accordance with the laws of the State of Nevada.
