6 2. (X) Obligor will pay \$487.00 per month as child support beginning 11/01/2008.

8 3. (X) A Judgment is entered against the Obligor for child support arrears in the amount of \$2,229.00 through 10/31/2008, and the Obligor will pay \$60.00 per month to retire the judgment beginning 11/01/2008.

11 4. (X) A Judgment is entered against the Obligor for genetic test costs and the Obligor will pay \$5.00 per month to retire the Judgment, once the arrearage judgment has been paid in full.

15 5. (X) The Obligor shall provide health insurance, including medical, dental, orthodontic, and ophthalmological coverage for the children if available through his/her employment at a reasonable cost, including any group health plan(s) under ERISA, from the date of this order on and until said child/ren are / is no longer eligible for said coverage, and both parties shall cooperate and provide assistance in obtaining payment for health care services. You are required to notify the Child Support Enforcement Office when health insurance coverage is available or has been terminated.

24 6. (X) The Obligor shall pay health care expenses, including medical, dental, orthodontic, and ophthalmological services for the children as follows: one half of all costs not covered by insurance, upon being provided by Obligee

with adequate documentation/billing regarding said expenses and any EOB or other insurance payment documentation.

- 7. (X) Obligor will be given a credit towards his monthly child support obligation which is equal to one-half of the monthly premium when proof is provided.
- 8. (X) A wage/income withholding shall be issued starting immediately.
- 9. (X) Pursuant to NRS 125B.145 this Order may be reviewed every three years and is subject to future modifications.
- 10. (X) All property is subject to actions for collection including, but not limited to, withholding of wages, garnishment, liens, and the attachment of Federal income tax returns.

PERSONAL CHECKS WILL NOT BE ACCEPTED.

Interest will be assessed on all unpaid child support balances for cases with a Nevada controlling order pursuant to NRS 99.040.

A 10% penalty may be assessed on each unpaid installment, or portion thereof, of an obligation to pay support for a child, pursuant to NRS 125B.095. If you pay your child support through income withholding and your full obligation is not met by the amount withheld by your employer, you are responsible to pay the difference between your court ordered obligation and the amount withheld by your employer directly to the state



1 disbursement unit. If you fail to do so you will be subject to the assessment of penalties
2 and interest.
